would like lodge this written complain
and inform you to the following effects:

1. That I have married with Dil Kumar Tamang on 6.12.2000 as per Buddhist Rites and Custom.
2. That since out of our said wedlock one insurer were born namely Ashwin Tamang was born on 2nd July 2003.
3. That after marriage my above named husband (Accused Person) Purchased one Residential building - Schedule below through loan from LIC Housing Finance Limited, in joint name where I am the co-Applicant.
4. That ~~initially~~ one Bank Account was opened by my said husband with joint Account in S.B.I Branch Stalin Nagar, Upper Bagdogra vide A/c NO 30430715733.
5. That initially the ~~loan~~ EMI of loan has been deducted from the ~~the~~ aforesaid Bank Account.
6. That after few months, I have been mentally and Physically tormented by my husband.

7. That suddenly my said husband without any giving intimation left the said house and till today I have no knowledge about my said husband.

8. That after some days I came to know that my husband intentionally with dishonest intention and fraudulently transfer the S.B.I Bank account to another Branch which is beyond my knowledge.

9. That my husband already knowing that the accounts were in a men's did not care to see that the amounts were duly credited, it can only lead to the inference that he was either grossly negligent in the discharge of his duties or that he had himself misappropriated the amounts.

10. That now one demand notice has been sent from LIC Housing finance Ltd under Securitization 13(2) of the securitization and Reconstruction of financial assets and Enforcement of Security Interest Act 2002 to me.

11. That I have no source of Income and my son who is till unemployed.

12. That from the above acts and activities of my husband, I along with my son are suffering deep mental pressure and agony. In this way my husband committed breach of trust with me.
