Sir,

In producing herewith 02 (Two) Female arrested accused person namely (i) Sallar Raihana (20Yrs) D/o Farhad Sallar, (ii) Sallar Sona (22Yrs) D/O Farhad Sallar both are resident of Islamic Republic of Afghanistan, along with following seized articles under proper seizure list:

1. Original Passport of Sallar Raihana Vide Passport No. P01410623 Valid up to 06 Feb 2027 corresponding Visa Republic of India Vide No. VK9044428.
2. One original Passport of Sallar Sona vide Passport No. P01411650 valid up to 06 Feb 2027 Corresponding Visa Republic of India Vide No. VK 9044425.

I, SI Sabin Yonzon Tamang of Matigara PS SPC do hereby lodge this written complain to the effect that today i.e. on 31.05.25 at about 21.10 hrs while I along with force performing mobile petrol van duty vide MCC No. 1422, Dated- 31.05.25 and GDE No. 2310, Dated- 31.05.25. On getting information from duty officer Matigara PS, I along with force assisted by lady police personnel as per direction of I/C PS, had been to Hotel Montana Vista, Utrayon Township under Matigara Police Station. On arrival at Hotel Montana Vista I found that two Afghanistan Resident came at said hotel for check in. But when they were asked to produced their identical proof they failed to produce valid visa.

Accordingly, I along with Lady Police personnel detained the said persons and interrogated them in presence of Hotel manager Sanjoy Sharma. On interrogation they disclosed their name and address noted above and also stated that they are from Islamic Republic of Afghanistan and came here to perform an event on 31.05.25 at Beer Republic Club, City Centre under Matigara PS. Then further interrogation I brought them to Matigara Police Station, on interrogation they disclosed, they were staying in India since 2019 without any Valid Visa. On search I recovered the following articles from their possession (i) Original Passport of Sallar Raihana Vide Passport No. P01410623 Valid up to 06Feb 2027 corresponding Visa Republic of India Vide No. VK9044428, (ii) one original Passport of Sallar Sona vide Passport No. P01411650 valid up to 06 Feb 2027 Corresponding Visa Republic of India Vide No. VK 9044425.

On enquiry I found that (i) one Visa bearing No VK9044428, Issued by Govt. of India on 18.10.2018 and date of expiry is on 17.10.2019, (ii) one Visa bearing No VK9044425, Issued by Govt. of India on 18.10.2018 and date of expiry is on 17.10.2019. Hence, I seized the above noted articles under proper seizure list in presence of witnesses as their period of VISA was already expired. I asked them to sign on seizure list but they were refused to do sign in the seizure list. As such the above noted person have committed offence liable to be punishment under section of the 14( ) of Foreigners Act 1946. They are directly violated the breaching visa condition or disobeying other orders or direction related to the act. If, I not arrest them, they may abscond permanently. Finding no other alternatives I arrested them u/s 35 (3) (6) of BNSS as they violated the section of 14 ( ) of Foreigner Act, 1946 in presence of LSI Bimala Karki Chhetri and Lady home guard NVF 01100028 Uma Roy, however they were refused to do sign in the arrest memo as well as Ground of arrest. Their ground of arrested has duly communicated them. The whole search and seizure was made in between 22.55hrs to 23.25hrs.

Hence, I pray that a specific case may kindly be started against the accused persons namely (i) Sallar Raihana (20Yrs) D/o Farhad Sallar, (ii) Sallar Sona (22Yrs) D/O Farhad Sallar both are resident of Islamic Republic of Afghanistan under proper section of law and arrange for its investigation.
