We disclosed our identity and on question he disclosed his name and address as Sushil Roy (M/42) S/O Late Deben Roy of Tikiya Para, Matangani Colony, near Hanuman Mandir, Ward No. 28, PS- Siliguri, Dist- Darjeeling. On search few Xerox fake Aadhar Card and one mobile phone having huge number of photographs of Suspected Aadhar Card of different names recovered from his possession. On further question he could not gave any satisfactory answer for having such number of photographs of Aadhar card. On interrogation he confessed that he along with one Indra Narayan Chowdhury (M/43) S/O Late Bijay Narayan Chowdhury, Sarkar Apartment, Fuleswari, Ward No. 30, Beşide Indoor Stadium, PS-Siliguri, Dist- Darjeeling are engaged in preparing fake Aadhar Card for the interested persons in lieu of money for their wrongful gain. Accordingly at about 20.05 hrs onwards, I seized (1) One black coloured Mobile phone (Vivo V-29 E) having IMEI No. 863405061594591 & 863405061594583 showing huge number of Aadhar Card in the Gallery, (2)One Printed Aadhar Card having No. 673731511007 in the name of Sima Rani Paul W/O Gopal Ch Paul , W/No 24, Guru Saday Dutta Road,Rabindra

Sarani, Siliguri, WB, 734006, (3) Photo Copy of Aadhar Card in the name of (a) Bikash Roy 5/O Dinesh Roy of Ward No. 06, Ganguli Benipatti, Madhubani, Bihar, 847223 having Aadhar No. 668716402465 enrolment No. 1429/70044/00209 (b) Bikash Roy of do having Enrolment No. 1429/70044/00208, Aadhar No. 656188133657 from his possession in presence of witnesses under proper seizure List and arrested him at 21.15 hrs U/S 35 BNSS after observing all formalities. Lalso informed him the ground of arrest in written.

In pursuing to his leading statement, I along with team went to the house of Indra Narayan Chowdhury at Sarkar Apartment, Fuleswari, Ward No. 30, Beside Indoor Stadium, PS-Siliguri, Dist- Darjeeling and apprehended him.
