Respected Sir,

With due respect I, SRI KANTI SEN, Son of Late Horolal Sen, Resident of Aurobinda Pally, Ward No. 22 of S.M.C, P.O. Rabindra Sarani, P.S. Siliguri, Dist. Darjeeling, Pln - 734006, would like to inform you that Smt. Sampa Sen is my legally married wife and our marriage was solemnized on 10.06.1985, according to Hindu Rites and Customs and out of our lawful wedlock, we have one son whose name is KUNAL SEN.

Sir, my wife is the absolute owner in possession of all that piece and parcel of land measuring 0.0534 acre, appertaining to and forming part of Plot No. 13478 & 13479, recorded in Khatian No. 5906/2, of Mouza - Siliguri, J.L. No. 110(88). Touzi No. 3/Jai. under the jurisdiction of P.S. - Siliguri, Dist- Darjeeling and she has acquired the said land by virtue of a Deed of Gift, executed by Smt. Mira Rani Das, Wife of Late Parcsh Chandra Das and Sri Suman Kumar Das, Son of Late Parcsh Chandra Das and the same was registered in the Office of the then Sub-Registrar Siliguri, being Document No. I - 2455 for the year 1992 and since then she has been Possessing, occupying, and enjoying the aforesaid plot of land in her actual khas and physical possession, having permanent, heritable and transferrable right, title, and interest therein, free from all encumbrances and charges whatsoever.

Mira Rani Das, Wife of Late Paresh Chandra Das and Sri Suman Kumar Das, Son of Late Paresh Chandra Das and the same was registered in the Office of the then Sub-Registrar Siliguri, being Document No. I - 2363 for the year 1992 and since then, she has been possessing, occupying and enjoying the aforesaid plot of land in her actual khas and physical possession, having permanent, heritable and transferrable right, title and interest therein, free from all encumbrances and charges whatsoever and thereby, conjointly, my --wife being the absolute owner in possession, has been possessing, enjoying, and occupying the total land measuring 0.0934 acre in her actual khas and physical possession, having permanent, heritable and transferrable right, title, and interest therein, free from all encumbrances and charges whatsoever and thereafter, I along with my wife have jointly constructed a three-storied dwelling house in and over the said landed property, as per the approved building plan, sanctioned and approved by the Sillguri Municipal Corporation and since then, I along with my family members started to reside thereon.

Sir, my said son namely Kunal Sen got married with one Smt. Salina @ Sabina Singh and his marriage was solemnized his marriage in the year 2016 with one SMT. SALINA @SABINA SINGH, Daughter of Tara Singh, Resident of Pedong, East Sikkim, and their said marriage was the outcome of their prior love and affairs relationship and following their marriage, my son and my daughter-in-law initially started to reside in a rented accommodation at Siliguri and later on, in the month of May 2022, both my son and my daughter-in-law approached me and my wife and requested us to allow them to reside in our house, and we being their parents, have also agreed with their said proposal and allowed them to reside in our house and since then, they have been residing with us in our aforesaid property. Sir, my son and his wife stayed with us for a period of only two months, and thereafter, they again got separated from us and began residing independently in a separate flat located within the same premises.

Sir, I am a senior citizen, and my wife, who is also elderly, has been suffering from serious health issues and she has been suffering from longstanding cardiovascular disease and has also previously undergone an Open-Heart Surgery and later on, she was also diagnosed with Cancer in the year 2024 and she is currently undergoing cancer treatment at R.N. Tagore Hospital, Mukundapur, Kolkata and moreover, the health condition of my wife remains critical as she continues to struggle between life and death, further affected by age-related ailments and complications.

Sir, now a days, my son and his wife have started tremendous torture upon me and my ailing wife and they repeatedly abused us using filthy and offensive language, and have even threatened us with dire consequences, and they have been subjecting us to continuous mental torture and harassment without any just cause and reason, and have completely neglected their responsibilities to maintain us and despite our old age and deteriorating health, my son and his wife have not contributed a single penny towards our maintenance or medical treatment and on the contrary, they have intensified their mental torture with the sole intent to compel us to leave and vacate our entire house in their custody, so that they may take possession of the entire property, even though they have no legal right, title, or interest in it, as the said property stands solely in my wife's name. Sir, myself and my wife have made several requests to them to refrain from their such behavior, but they have intentionally tortured us and as a result of their harassment and torture, I along with my sick wife are being deprived of our right to live peacefully in our own home during the remaining years of our lives.

Sir, very recently, my son and his wife have escalated their mental harassment towards us and have started creating undue pressure to compel us to transfer all our property in their names and moreover, they have also threatened that if we fail to transfer all our property in their names then, they will forcibly evict us from our own house and these threats are being made with full knowledge that my

wife is critically ill, suffering from a scrious heart condition, and she is currently undergoing treatment for cancer and despite knowingfully well and being aware of my wife's fragile health condition, my son and his wife have continued their acts of cruelty and mental torture upon us with a sole intention to evict us from our own property. Moreover, my son and his wife did not bother to take any information about our health, medical treatment, and maintenance, and on contrary, they are increasing their mental torture upon us day by day to fulfill their malafide intention for their wrongful and illegal

Sir, my son and his wife are abusing me and my ailing wife with filthy and abusive languages and also threatened us with dire consequences and due to their said torture, my wife had fallen ill and could not sleep throughout the night and for which, my health condition is deteriorating day by day and if they are not restrained immediately, my wife may not survive due to their continuous mental torture.

I, therefore, being a Senior Citizen, fervently request you to look into the matter properly and please take appropriate legal steps against my son and his wife as per the provision of law and obliged thereby.
