**Subject:** Complainant against husband and his family for dowry harassment, mental and physical torture.

Respected Sir,

I Suman Kumari Singh D/O Sri. Sankar Singh W/O Rohit Kumar Sah resident of Durga Nagar Colony, near Model School Pradhan Nagar, Siliguri, Dist- Darjeeling in the State of West Bengal – 734003, would like to inform you that I got married to person namely Rohit Kumar Sah on 2<sup>nd</sup> March 2025 as per Hindu ritual, from the beginning of the marriage, my husband (Rohit Kumar Sah) and his family members – including Parmanand Sha (father-in- law) 2)Sushila Devi (mother- in-law) R/O, Near Model High School P/O,+P/S, Pradhan Nagar District Darjeeling began harassing me mentally and physically for dowry.

Despite the fact that my family fulfilled all their demands during the wedding to the best of their ability, they were not satisfied and began asking for more money and expensive items such as gold jewellery, a car and money. They would insult me, taunt me, and say things like, "Tumhare maaa baap ne kya diya hai? kuch bhi nahi diya hai jao apna ghar se mang k lao ni toh tum apna ghar jao mang k aalo ni toh tmko maar dalega .......

I was constantly abused and beaten by my husband on trivial issues. His parents supported his behaviour and often encouraged him to do torture and physical

assaulted for dowry and I have suffered both physical injuries and emotional trauma due to this continuous harassment.

The situation has worsened in the last few weeks. My husband recently told me in a threatening tone, "Agar dowry nahi laogi, to main tumbe jala dunga aur kisi ko saboot bhi nahi milega." ("If you don't bring dowry, I will burn you and no one will find the evidence.") This terrifying threat has left me in fear for my life.

I am currently staying with my parents due to the unbearable torture and life-threatening threats from my in-laws' side. And one day my husband directly came to my home at about night 1:07 am. on 25/05/2025 in very drunk condition and thread me along with my family members.

So, under the above circumstances I therefore request you to kindly inquire the matter immediate and record this Complain as F.I.R. and take a necessary legal action against above the noted persons and stop him to do any future criminal act for the ends of justice.

And for this act of duty, I shall always remain indebted to you.
