With due respect, I SI Rabindra Nath Sarkar of Matigara P.S SPC would like to lodge this written complaint against 80/100 unknown persons all are supporters of VHP to the effect that today i.e 02/06/2025 at around 07:00 hrs in course of my Special QRT Van duty received information that some supporters of VHP put a road blocked at Thokkor under Matigara PS area. Accordingly, I along with my accompanied force had been to Thokkor and found approx 50/60 unknwon persons all supporters of VHP have obstructed the road forcefully in favour of "24 hours Bundh" called by V.H.P. also burning Tyres on the said road. As a result Traffic movement on the road from Sutki Godown, Matigara towards Thokkor were totally stopped and around 60 vehicles of both side at Thokkor were compelled to fall in jam. A huge chaos was cropped up in this regard. I tried hard to regularize the traffic flow but in vain. However after prolonged talking with the road blockaders at about 12:50 hrs, they withdrew the road blockade.
