I, SMT. ANITA MANDAL, wife of Sri. Lakshan Basunia and daughter of Sri. Khagen Mandal, resident of Ramkrishna Nagar 2, Ward No.47 of Siliguri Municipal Corporation, P.O. & P.S.- Pradhannagar, PIN- 734003, District- Darjeeling in the State of West Bengal, would like to inform you that on 10.03.2022 my marriage was solemnized with my husband namely Sri. Lakshan Basunia in the presence of our family members and relatives as per Hindu rites and customs at my aforesaid address, at the time of the marriage, as per the demand of my husband and in-laws namely Sri. Panchanan Basunia (my father-in-law), Smt. Maya Basunia (my mother-in-law), Sri. Ramu Basunia (brother of my husband) and Smt. Dipa Basunia (wife of said Ramu Basunia), my father had given gold ornaments and other household articles including furniture and electronics items and also a sum of Rs.2,00,000/- [Rupees (Two Lacs) Only] by cash, after solemnization such marriage, I was taken to my matrimonial home at Baghajatin Colony, Near Mukta Manch, P.O. & P.S.- Pradhannagar, PIN- 734003, District- Darjeeling (Contact No.7865886155/8670243013) and I brought my all those Stridhan properties and as per the instruction of my husband, I handed over all the aforesaid articles to my husband and in-laws and which is presently under their custody.

Therefore we started to live together as husband and wife, but after passing about one month of the said marriage, I found drastic changes in his attitude and behavior towards me as he started to come home late night

in drunken condition and abused me in most filthy terms by throwing slangs upon me and making abusive remarks over my family members. My husband always pressurized me to bring more money from my father, when I convince him that my father is a poor layman and incapable of fulfilling the said monetary demand, my husband outrageously tortured me on frequent occasions by physically assaulting me in most brutal and inhuman manner with the support of my above-mentioned in-laws. After three months of my marriage, my husband and I shifted to my personal residential accommodation situated at Ramkrishna Nagar 2, Ward No.47 of Siliguri Municipal Corporation, P.O. & P.S.- Pradhannagar, PIN- 734003, District- Darjeeling.

That soon after shifting to that premises as aforesaid, immense mental and physical torture started upon me by my husband and on several occasions my husband physically assaulted me upon the influence of alcohol. I found that my husband has started to participate in gambling and he lost almost my money and on protest, my husband subjected me to brutal assault. It is pertinent to mention here that my husband has many debts and many people threaten him to return their money and in the month of April, 2025 I found that my husband has started extra marital affair with a number of women. When I tried to convince my husband not to maintain such extra marital affair he brutally assaulted me with kicks and blows abusing most filthy languages upon me and then he tightly hold and pressed my throat with his hand with the intension to kill me, somehow I managed to escape from his clutches and took shelter at my parental house with the grievous physical injuries and after that incident, my husband left for his own house and started living with his family members and at present I am still living at my said personal residential accommodation. We have been separated since that day.

On 16.05.2025 my husband tried to commit suicide by consuming poison at his own house then he was brought by

his family members to Siliguri District Hospital and he was treated there.

After the said incident, I became very shocked and under serious apprehension that if I will go to my matrimonial house, he alongwith my in-laws will kill me for the non-fulfillment of their illegal demand and after few months of my marriage, due to mental torture created by my husband towards me in several times, I became hypertension patient and I am on my regular medication as per my doctor advise since December 2023.

Under the aforesaid circumstances I being a helpless lady finding no other alternative, lodge this complaint against my husband and abovementioned in-laws.

It is my humble request to you to look into this matter at the earliest in order to save my life and liberty from my husband and in-laws and take immediate and necessary actions against them.
