Sir,

I, SI Suraj Kr Chhetri (51 yrs) S/O Lt. Bhim Kr Chhetri, of the Cyber Crime PS, Siliguri Police Commissionerate, hereby lodge a written complaint stating that today, on 31.05.2025, at approximately 15:45 hrs, while I was engaged in social media monitoring duty at Cyber Crime PS, Siliguri, I found numerous communal provocative posts on social media platforms (Facebook) regarding an incident on 30.05.2025, in which a vehicle was intercepted by local people at Balasan Bridge, Matigara, and set on fire for allegedly illegally carrying beef, driven by a Muslim individual. In relation to this issue, many hateful comments and video speeches are circulating on social media, inciting enmity between two communities based on religious grounds and actions that are prejudicial to the maintenance of harmony. The content of these posts as well as audio messages circulated through social media close group and messaging app and poses a severe threat to communal harmony with criminal conspiracy to provoke to breach of communal harmony and has the potential to provoke violence and unrest among communities within the local jurisdiction which could lead to a breakdown of law and order. I aim to prevent disharmony, hatred, and ill-will between religious, racial, linguistic, or regional groups or castes.

Hence, I pray that you kindly register an FIR against the user of the social media profile under proper section of law and take necessary action to remove the offending material from the respective social media platform, and conduct an investigation into this matter.
