Sir,

I, SI Bikash Kisku (52 yrs), S/O Lt. Gopal Kisku, of the Cyber Crime PS, Siliguri Police Commissionerate, hereby lodge a written complaint stating that today, on 31.05.2025, at approximately 16:45 hrs, while I was engaged in social media monitoring duty at Cyber Crime PS, Siliguri, I found several communal provocative posts on social media platforms (Facebook) regarding an incident where a group of people ransacked a residential house belonging to a Hindu family, physically assaulted family members, and issued threats. In relation to this incident, hateful comments are circulating on social media, spreading enmity between two communities with criminal conspiracy. This content is prejudicial to the maintenance of harmony and poses a severe threat to communal cohesion. It has the potential to provoke violence and unrest among communities within the local jurisdiction.

Hence, I pray that you kindly register an FIR against the user of the social media profile under proper section of law and take necessary action to remove the offending material from the respective social media platform, and conduct an investigation into this matter.
