With due respect I, SI Sailesh Subba of Bhorer Alo P.S, SPC would like to lodge this written complaint against arrested accused person namely Pabitra Biswas (48) S/O- Lt. Khagendra Nath Biswas of Shelter Bari, Balaram, PS- Bhorer Alo PS, Dist- Jalpaiguri after producing the following seized articles under proper seizure list viz:

Thirty (30) sealed Bottles of "BAZIGAR' 70UP IML India Made Liquor each bottle each bottle containing 300 ml when packed which is labelled and marked as "Exhibit-A" out of which one bottle is taken as sample and marked as "Exhibit-A1". [Total 30 X 300 ml = 9 Litres]

to the effect that today on 02.06.2025 at about 11.25 hours I along with force while performing my special van duty under Bhorer Alo Police Station vide Bhorer Alo PS GDE No. 59, Date: 02.06.2025 received a source information that one Pabitra Biswas of Shelter bari is selling illicit liquor in his shop situated at Gander More. The matter was informed to Officer-In-Charge, Bhorer Alo PS over phone and as per his kind order myself along with force of Bhorer Alo PS left for Gander More under Bhorer Alo PS to verify the information.

At about 11.35 hours I along with force reached at Gandermore and being shown and identified by the source I along with force held raid at the shop of said Pabitra Biswas and apprehended him. On enquiry he disclosed his identity as noted above and on being searched found the above noted seized articles from his shop.

On further enquiry it came to learnt that he has been involved in selling and possessing of illicit liquor in his shop since long without any valid license for his illegal gain. The accused person Pabitra Biswas has violated the norms of Bengal Excise Act. Hence, I seized the above mentioned liquor under proper seizure list after observing all sorts of formalities at the spot. The whole process of seizure and label has been made on 02.06.2025 in between 11.45 hours to 12.00 hours.

Under the above noted circumstances I, pray before your good self that a specific case under proper section of law may kindly be initiated against absconded accused person namely Pabitra Biswas (48) S/O- Lt. Khagendra Nath Biswas of Shelter Bari, Balaram, PS- Bhorer Alo PS, Dist- Jalpaiguri and may arrange to cause its investigation under Bengal Excise Act.
