With due respect I Arun Kumar Das Son of Sri Ram Shankar Das, resident of Demdema, Under Dab Gram Panchyat I, P.O Salugara, P.S Bhaktinagar, Dist Jalpaiguri(West Bengal) begs to state that on 31.05.2025 at about 11.30 P.M suddenly without any reason **KALPANA SINGH** Wife of Indra Singh, resident of Demdema, Under Dab Gram Panchyat I, P.O Salugara, P.S Bhaktinagar, Dist Jalpaiguri(West Bengal), forcefully enter into in our compound at the relevant time my mother Laxmi Das and my father Ram Shankar Das was present. That Kalpana Singh was knocking the front door of our residence continuously and compelled my mother to open the door, as and when my mother open the door Kalpana Singh forcefully enter the room with a sharp scissor. That my mother somehow able to force her out from our room. That Kalpana Singh attack upon my mother with scissor but my mother somehow manage to save herself and she sustain injury in her body. That my mother started shouting for help and after hearing the loud voice of my mother, my father came out and snatch away the scissor from the hand of Kalpana Singh. That thereafter **DHIRAJ SINGH** Son of Indra Singh and **WANGDI** brother in law of Kalpana Singh, S/O not known all are resident of Demdema, Under Dab Gram Panchyat I, P.O Salugara, P.S Bhaktinagar, Dist Jalpaiguri(West Bengal) came in our residence with wooden battem and sharp weapon, they started jointly quarreling with my mother and father. That Wangdi with an intention to disrobe my mother beat my mother with wooden battem. That they make an attempt to grievous hurt to my mother with an intention to kill her. That my father save my mother life and snatch wooden battem from them. That scissor and wooden battem is lying there in our compound. That there after my mother and father raised loud voice and after hearing the loud voice local people started gathering near our house and seeing the local people they left the place with a threat to kill my mother. That they are very desperate in nature and every possibility that they take the laws in their hand. That my family member did not lodge any written complaint on time because we are very much afraid from their activities.

So, I therefore request before you to kindly look into the matter and do the needful under the provision of law and start specific case against the accused person. I shall be highly obliged for this act of kindness.
