Sir,

This is to inform you that I KIran Sarkar Biswas, aged about 40 years, wife of late Raghunath Sarkar, resident of Eastern bypass, Ashighar colony, Ward No. 2 of S.M.C. P.O. Ghoogomali, P.S. Bhaktinagar, Dist- Jalpaiguri am law abiding citizen. I beg to state you that yesterday i.e. on 30/05/2025 at around 10.00 pm at night my stepsons namely Omkar Sarkar and Swastik Sarkar, both son of late Raghunath Sarkar, resident of Eastern bypass, Ashighar colony, Dabgram -II, Dabgram(P). P.O. Ghoogomali, P.S. Bhaktinagar, Dist-Jalpaiguri came to my residence and started to knock heavily on my door, hearing such I opened the door and the said Omkar Sarkar and Swastik Sarkar along with their wife Neha Sarkar and Priyanka Sarkar started to abuse me with filthy languages and threats and were forcing me to leave my house along with my son namely Souniv Sarkar, who is 9 years old, upon witnessing such situations I was shocked but in the mean time the said Omkar Sarkar, Swastik Sarkar along with their wife Neha Sarkar and Priyanka Sarkar dragged me out of my house holding my hairs threw me outside in heavy rain, they further attacked my son namely Souniv Sarkar. Facing such situations I requested them to let us stay in our house but denying all my requests they got more furious and started to hit me with kicks and punches in my head, breasts, and stomach, facing such situations I got so shocked I fell to the ground but still the above said persons continued to hit me and even tore apart my clothes. Although I was shocked to my core but I somehow managed to get me and my son out of the situation by locking ourselves in our room. That I would also like to mention that I am getting tortured by the above named persons since a long time and I was also threatened that if I seek any kind of help from anyone than they will kill my son. On past days the said Omkar Sarkar, Swastik Sarkar, Neha Sarkar and Priyanka Sarkar used filthy languages to degrade my modesty amongst my village, they even vandalized my toilet seat, ripped off my water pipes. I am a daily household worker in Dabgram -II, Anchal Office but the said persons created many obstacles/situations to make me quit my job, such as locking me inside of my room while working hours, they even interrupted my sons education by not letting him go to the school regularly. For torturing me the said Omkar Sarkar, Swastik Sarkar, Neha Sarkar and Priyanka Sarkar, use to bang into my door at midnight and wake me up just to disturb my peace. They even threw my elder son namely Sourav Bhowmick out my house and threatened him not to come in my residence again and if he does he shall face dire consequences.

So finding no other alternatives and being helpless I am writing you this written complaint to take appropriate/strict legal actions against the above mentioned Omkar Sarkar, Swastik Sarkar, Neha Sarkar, Priyanka Sarkar at the earliest and he help me survive in this situation.
