

Sir,

In producing herewith the following accused person namely Soni Majhi (22 yrs) S/O Late Madan Majhi of Gulma Bagan, Nicha Basha, PS- Pradhan Nagar, Dist. - Darjeeling under arrest and the following articles under seizure viz :- (i) One Truck having registration number WB/76/0887 loaded with illegal River bed materials under proper seizure list. I, ASI Sanjit Mandal of Pradhan Nagar PS, SPC do hereby lodge this complaint against the the above noted arrested accused person namely Soni Majhi (22 yrs) S/O Late Madan Majhi of Gulma Bagan, Nicha Basha, PS- Pradhan Nagar, Dist. - Darjeeling and the owner of the said seized vehicle to the effect that on 04.06.25 at 07.00 hrs myself along with force left the PS to perform RT Mobile van duty (K-29) vide Pradhan Nagar PS GDE No 171 dated 04.06.25. During my duty I received a secret source information that one Truck having registration WB/76/0887 loaded illegal river materials from Mahananda river bed and proceeding towards Champasari. Accordingly, I informed the fact to you over mobile phone and as per your kind order and direction myself along with force had been to Military Ghat under PS Pradhan Nagar, Dist. Darjeeling. At around 08.25 hrs we detained the said truck displaying number plate WB/76/0887 loaded with illegal River bed materials at near Militari Ghat under PS- Pradhan Nagfar, Dist.- Darjeeling and also found that the driver was inside the cabin of the said truck. On being asked he disclosed his name and identity as noted above. On demand he failed to produce any valid documents in respect of illegal river bed materials loaded in his vehicle. On further interrogation he disclosed that he with the help of his owner mines such river bed materials from Mahanda River by illegal means with a view to sale the same to their design customers for their illegal gain. Accordingly, I seized the above noted vehicle having registration number WB/76/0887 leaded with illegally mining river bed materials under proper seizure list and subsequently arrested him after maintaining all formalities of arrest and brought to Pradhan Nagar PS for further investigation. to 09.25 hrs. at the spot under the The search and seizure was made in between 08.55 coverage of videography.

Under the above noted fact and circumstances, I therefore, I pray before you that a specificcase under proper section of law may kindly be started against the arrested accused person namely Soni Majhi (22 yrs) S/O Late Madan Majhi of Gulma Bagan, Nicha Basha, PS- Pradhan Nagar, Dist. - Darjeeling and the owner of the said seized vehicle and arrange for its investigation.
