I NIKITA UPADHYAY (TIWARI), wife of Pawan Upadhyay, Daughter of Ajay Tiwari, residing atMatigara, Anil Nagar, Patiram Jote, P.O & P.S Matigara, Dist.- Darjeeling, Pin-734010 would like to inform you: -

- That I got married with Pawan Upadhyay, sen of Hari Shankar Upadhyay, on 25thApril, 2022 at Rishi Bhaban, Bardhwan Road, Siliguri our marriage was arranged marriage solemnize with Hindu rites and custom.
- 2. That after our marriage I went to my matrimonial house which is situated atGanganagar, Siliguri(M. corp.), Siliguri, Dist.- Darjeeling. Pin code- 734005.
- That after passing one day of our wedding i.e. on my reception day my in-laws started misbehaving with me. They didn't let me eat anything all day and I got sick.
- 4. That after the day of our reception my sister in-law namely Sova Upadhyay started abusing me verbally and she said "You're came from a poor family" and also, she speaks bad about my skin color and face. My mother in-law called me as "Kali-Mai".
- 5. That ten days when my mother came to my matrimonial house to give them invitation for my nephew's birthday suddenly my mother in-law started using filthy languages towards my mother and me, andat that timemy husband told me that get out from my house. And after such incident me along with my mother came to parental house.

SOLUS

- 6. That afterpassing one month my parents and well-wishers returned me to my matrimonial house. They didn't bring me back but after several request they accept me.
- That after few days I came to know that my husband consuming alcohol in a daily basis and day to day he started assaulted me physically after consuming alcohol.
- 8. That on August,2022 I came to know that I am pregnant. In my pregnancy period my in-laws started torturing me physically due to deteriorate my health condition and my husband also doingforcefully intercourse with me. And after passing three month I came to know that I have miscarriage.
- 9. That on January,2023 I was pregnant second time. At my second pregnancy period one daymy mother in-law slapped me in front of my husband, father in-law and sister in-law. They treated me as a servant. And at that time my husband was not doing any work, he totally depends on his father's income. And my husband leave me in my parental house.
- 10. That on 18th October,2023I gave birth one son at Arogya Niketan nursing home, Siliguri. At that time my father in-law and my mother in-law came to meet me. And due to health issues ofmy son,he died after six days of his birth. It is pertinent to mention here that my in-laws forcefully discharge me from the mentioned nursing home and admitted us at Siliguri medical.
- 11. That from such day, my in-laws and my husband never tried to contact me. Whenever my parents and well-wishers tried to contact with them, they always ignored them and intentionally told my parents that they will bring me in their house after completed their house. On several occasion my family members and well-wishers was going to my matrimonial house to solve all the problem but they never talk with them and always misbehaving with them.
- 12. That whenever I tell them about my daily expenses, my husbandsaying that you are no one for me. It is very harsh to survive me with the expenses; my husband and his family did not give single rupees.

- 13. That after passing few months I came to know that my husband has extra marital affair with one lady and the lady always visit my matrimonial house. Whenever I told them I will go to the police station, they always threaten me and said that if I go to the police station, they will kill me and my parents.
- 14. That on last occasion i.e. 19th May, 2025 when I tried to contact with them, they clearly refused me to bring me in their house. And threaten me to give divorce to my husband.
- 15. That yesterday i.e. on 31/05/2025 I came to know that on 2nd June, 2025 my brother in-law will get marry and they never told me about this.
- 16. That my husband and in-laws started torturing me both physically and mentally and threaten me to give him divorce or else they will kill me.
- 17. That I am suffering from depression and anxiety due to my husband, father in-law, mother in-law, and sister in-law.

It is pertinent to mentioned you that firstly, I went to Matigara Police Stationto lodge the F.I.R. but they refused to take the F.I.R. due to unknown reason.

Therefore, my humble request to you take an immediate action against the above noted persons for the ends of justice.
