Respected Sir,

I, ASI Bishnu Das, presently posted to Siliguri PS under your kind disposal filing this written complainant against 12 to 15 leader and supporters of **Vishwa Hindu Parishad** to the effect that on 02.06.2025 the **Vishwa Hindu Parishad** has called on a 24 hrs. illegal strike from 02.06.2025 from 06.00 hrs to 03.06.2025 at 06.00 hrs in and out Siliguri PS area. Accordingly to maintain law and order situation I was deployed at Sevok More under Siliguri PS Vide MCC No. 1860/25 Date 02.06.2025. Till 12.00 hrs the situation was normal at Sevok More area and at about 12.35 hrs I found that a group of 12 to 15 persons coming towards Sevok More from Airview More side by raising slogans and by blocking the free flow movement of the traffic, on arrival at Sevok More suddenly they became aggressive and started forcefully blocking vehicles and commuters and also ordinary shop keepers were being forced to close their business in support of the 24 hrs. Strike called on by **Vishwa Hindu Parishad**, accordingly I along with officer and force intervene the situation and started make them understand that the Strike they are supporting is illegal and they have no legal right to impede the vehicle movement as well as the commuters also shop owners has the right to run their business as they are not willing to take part in the said strike, over all the act they are performing is not legal and it may create panic in the public in general as it is the Monday and people are going to their work places and it creating great inconvenience to them. They did not want to understand these things and continued their activities and demonstration in the presence of me and other Police personnel. Then I direct them to control their activities and as they are assembled unlawfully in middle of the road and creating public inconvenience but in vain, they wilfully violated the lawful direction of on duty Police. Then I started to remove them from the spot and tried to take control over the situation to avoid any adverse situation, seeing the Police tried to take control they became aggravated and intentionally started raising sensitive slogans indicating me as well as the other on duty Police personnel. In spite of cooperation and obeying the lawful direction of Police they became aggressive and voluntarily obstruct on duty Police personnel in the discharge of our public functions and started using criminal force to us. In between this some of the supporters brought out a tyre and set on fire over the tyre in the middle of the road. Seeing the situation going out of control and finding no other option I along with force finally tried to detain them but seeing the attempt all of the strike supporters poured water on the burning tyre and fled away from Sevok More.

Therefore I pray before you a specific case may kindly be initiated against the illegal strike supporters of **Vishwa Hindu Parishad** for illegally assemble at Sevok More, violating the lawful direction of on duty Police personnel, obstructing the traffic and public servant in the discharge of their duty, uses ill wards to the Police personnel and also for mischievous activities by set on fire on a tyre in the middle of a public road and request you to arrange for it's investigation. Sir I also to state that as it was a 24 hrs Strike from 02.06.2025 from 06.00 hrs to 03.06.2025 at 06.00 hrs it took time to file this written complaint.


