This is to inform you that, as reported by Sri Siddharth Kr. Singh (Cell No. 93395-34737) & Sri Debabrata Chakraborty (Cell No. 89182-26103), Security Guards of Siliguri Municipal Corporation today i.e. on 03/06/2025 (Tuesday) at about 1:30 p.m. while the Security guards of Siliguri Municipal Corporation were on duty in the main gate, around 20 to 25 supporters of Bharatiya Janata Party (BJP) and Communist Party of India Marxist (CPI(M)) started agitating and shouting outside the gate. There were police personnel present inside the Office premises of SMC. And they told them not to open the gate. As per their direction the main gate was closed. Subsequently few unknown supporters of both parties became ferocious and started pushing the main gate to enter inside the Office premises and damaged a portion of the frontal part of main gate.

Therefore I request you to take necessary legal action against the aforesaid miscreants as per the relevant provisions of law.
