

I, Sub-Inspector Paresh Barman of New Jalpaiguri Police Station, Siliguri Police Commissionerate, in producing herewith following arrested accused persons viz.,

Accordingly I along with LASI Anamika Ghosh and other officer and force went to the spot and asked them not to halt the movement of traffic due to which there was a huge traffic jam and the passengers were facing hardship to reach their concern destination. But they did not pay any heed to my legal instructions. I also announced the gathering to be unlawful and asked them to disperse peacefully. But in spite of my repeated request/ instruction the supporters who had gathered there became agitated and violent and also started to threaten the Police. As the supporters did not pay any heed to the announcement, finding no other alternative way and to avoid commission of further cognizable offence, I arrested the above noted persons after observing all the formalities of arrest, but in the process of arresting the other supporters fled away from the spot.

Under the above circumstances I pray a specific case u/s 189(2)/223/190/351(2)/3CS BNS may kindly be registered against the above noted arrested accused persons and others and arrange for its investigation.
