Sir,

With due honour I Sri Prem Nath Prasad son of Sri Ganga Prasad Kurmi resident of village-Haripur, P.O. Sahudangi Hat, Police Station -New Jalpaiguri, District-Jalpaiguri do hereby beg to draw your kind attention towards the atrocities committed by Tapan Prasad and his companions.

That I am the owner of 1004 Sqare Feets of land along with one storied pucca residential structure appertaining to R.S. Khatian No. 442/5 corresponding to L.R. Khatian No. 156, R.S Plot No. 152 corresponding to L.R. Plot No. 65, J.L.No. 02, R.S. Sheet No. 19 corresponding to L.R. Sheet No. 200, situated within Mouza-Dabgram, Pargana-Baikunthapur, P.O. Sahudangi Hat, Police Station-New Jalpaiguri earlier Bhaktinagar, District – Jalpaiguri by virtue of Registered Gift deed, being Gift deed No. 165 dated 07.01.2021 executed by the then recorded owner my mother late Koushallya Devi wife of Sri Ganga- Prasad Kurmi resident of village-Haripur, P.O. Sahudangi Hat, P.S. New Jalpaiguri, District-Jalpaiguri in favour of me which was duly registered before A.D.S.R. Bhaktinagar, District-Jalpaiguri. That after getting the said land by virtue of gift deed from my mother, I have been enjoying the said land without any obstruction and free from all encumbrances.

That my mother Kaushallya Devi purchased 06 kathas (10 Decimals) of land including the suit land from Srimati Jolly Sharma Majumdar wife of Sri Jitesh Ranjan Sharma Majumdar of Millanpally Siliguri, P.S. Siliguri, District-Darjeeling through Registered Sale Deed being sale Deed No. 5173 dated 04.12.1987 duly registered before the District Sub Registrar, Jalpaiguri. That my mother Kaushallya Devi was the recorded owner of the suit land & during L.R. Operation the L.R. Khatian being No. 106 was opened in the name of my mother in respect of L.R. Plot No. 65.

That Srimati Jolly Sharma Majumdar wife of Sri Jitesh Ranjan Sharma Majumdar of Millanpally Siliguri, purchased the said 06 kathas (10 Decimals) of land appertaining to R.S. Khatian No. 442/5 R.S Plot No. 152, J.L.No. 02, R.S. Sheet No. 19, situated within Mouza- Dabgram, Pargana-Baikunthapur, P.O. Sahudangi Hat, Police Station-New Jalpaiguri earlier Bhaktinagar, District – Jalpaiguri from Sri Raghunath Roy son of late Shib Nath Roy of Dabgram, P.S. Rajganj at present New Jalpaiguri, District-Jalpaiguri duly registered before the District Sub Registrar, Jalpaiguri. That Raghu Nath Roy was the original R.S. Khatian Holder.

That after obtaining the said land by virtue of gift from my mother I took possession over the said land and I have been enjoying the same without obstruction from any corner. That I obtained Holding No. being No. 6933 in respect of my house situated on the said land, from the Fulbari I Gram Panchayat and paying holding tax regularly. That I am also paying the land revenue regularly to the Government of West Bengal.

That after obtaining and taking possession of the above mentioned land I applied for mutation and after proper verification and measurement the BL & LRO Rajganj mutated my name in respect of the said land mentioned above and L.R. Khatian is opened. That the L.R. Khatian No. 156 comprising L.R. Plot No. 65, J.L.No. 02, L.R. Sheet No. 200, land measuring 0.0250 acre or 2.50 Decimal under Mouza-Dabgram , P.O. Sahudangi Hat, P.S. New Jalpaiguri, District-Jalpaiguri, is opened in my name.

That I beg to state that the miscreants 1. Tapan Prasad son of Ganga Prasad, 2. Sima Prasad wife of Tapan Prasad, 3. Ratan Prasad @ Tuntun Prasad son of Ganga Prasad, 4. Sanju Prasad wife of Ratan Prasad, 5. Rohan Prasad and 6. Rahul Prasad son of Ratan Prasad, 7. Malia Prasad and 8. Manisha Prasad daugthter of Ratan Prasad having no right, title, interest, possession on any portion of the said land in any manner, have been trying since 20.04.2023 with greedy eyes having sole object to grab my above mentioned land.

That being aggrieved I filed a Title Suit against the above named miscreants before the learned Civil Judge Junior Division 1st court Jalpaiguri vide Title Suit No. 447/2023 and on 10.07.2023 learned Civil Judge Junior Division 1st court Jalpaiguri passed an Ad-interim injunction order –"that the defendants and their men and agents are hereby restrained from entering into the suit schedule land forcibly till 10.8.2023". That the said Ad-interim order of injunction is subsequently extended on each date of T.S. No. 447/2023 and now the said Ad-interim injunction is extended till 24.06.2024. The Xerox certified copy of all orders of T.S. 447/2023 are attached herewith for your kind perusal.

That on 12.6.2024 I filed a petition u/s 151 of C.P.Code before the learned court praying for Police help and on 20.08.2024 as well as on 28.08.2024 learned Civil Judge Junior Division 1st court Jalpaiguri passed order directing you to keep vigilance into the matter ensuring that the court's order will not be violated in any manner causing any serious breach of peace in the suit land and learned court also sent the copy of order dated 20.8.2024 and 28.8.2024 to you.

That in spite of being restrained to enter into my land mentioned above the above named miscreants are still trying to grab my land forcibly by violating the order of learned Civil Judge Junior Division 1st court Jalpaiguri & on 28.05.2025 started making construction upon my land and structure which is barred by law .That the above named persons attacked upon me, abused me and my family members and threatened me with dire consequences when I resisted them to do so. That the above named persons state that they have money and muscle power by virtue of which they can go to any extent and they do not bother any court order.

Under the above circumstances I humbly request you to kindly look into the matter and please take appropriate action upon them for violating the court order in c/w T.S. No. 447/2023 and please keep strong vigil over the said land mentioned above as per order dated 20.8.2024 & 28.08.2024 passed by learned Civil Judge Junior Division 1st court Jalpaiguri so that the above named miscreants shall not enter in to my above mentioned land or make any construction fully mentioned above and so that I shall be highly grateful to you.
