. With due respect, I am producing herewith the arrested accused persons namely (i) Md Khabin Hossain (M/25) s/o Umar Ali of Nischitpur, PS. Dalkhola, Dist. Uttar Dinajpur (Not verified) (ii) Wajed Ali Mollah(M/22) s/o Babar Ali Mollah of Simultapu no. 3, PS. Gosaigaon, Dist. Krokrajhar, Assam (Not verified) along with the following seizure:-

1. One truck having registration number BR-28/GA-1786 loaded with 08 (Eight) numbers of Cow.

2. Total 08 (Eight) nos of cow in different size and different colour.

I. PSI Sahanur Rahaman of NJP P.S. Siliguri Police Commissionerate, do herby lodge this written complaint against the above noted arrested persons to the effect that on 04.06.25 at about 13.30 hrs while I was performing Spl mobile van duty under NJP PS area, with C/1473 Gautam Roy and C/314 Anjan kr Mahato 'of NJP PS vide NJP PS GDE no. 153 dated. 04.06.25, after receiving a source information regarding illegal transportation of cow and as earliest informed IC/PS regarding the information, and as per his direction intercepted the above noted vehicles bearing BR-28/GA-1786 loaded with 08 (Eight) numbers of cow at Fulbari Canel Road at Gothmabari under New Jalpaiguri PS area which was coming from Ghosh Pukur side towards Assam. On being asked the driver and labour disclosed their identity as above and stated that they were carrying the Cow from Panjipara Hat to Meghalaya. On demand they could not produce any valid documents for being possession of the cattle nor any live stock permit of the above noted Cow loaded in the said vehicle. Even no any valid papers could be produce in r/o of the vehicle in which the cow was loaded. It was also found that the cattle's were kept in such manner causing to unnecessary pain and suffering to the cattle's. Accordingly I seized the vehicle bearing no.BR-28/GA-1786 along with the loaded 08 (Eight) nos of Cow seized under proper seizure list duly signed by the witnesses and arrested the above noted accused driver and labour informing them the cause of their arrest and issued notice duly sign by the arrested persons. It was reasonably believed that the above noted driver of the vehicle and the labour both are obtained the cattle's either by stolen or fraudulent means as there was no any documents produce in support of the same nor they could indicate the source of its procurement. Then I deposited all the 08 (eight) nos of Cow to the Khoar situated at Amaidighi, Fulbari under NJP PS. Dist. Jalpaiguri. Whole process of search and seizure made between 13.30 hrsto 14.00 hrs.

Under the above fact & circumstances I therefore request you to start a specific case under proper section of law against the above noted drivers namely (i) Md Khabin Hossain (M/25) s/o Umar Ali of Nischitpur, PS. Dalkhola, Dist. Uttar Dinajpur (Driver of vehicle no.BR-28/GA-1786) and (ii) Wajed Ali Mollah(M/22) s/o Babar Ali Mollah of Simultapu no. 3, PS. Gasaigaon, Dist. Krokrajhar, Assam (Labour) and arrange for the investigation.
