Sir,

In producing herewith following seized articles as per seizure list viz:- (i) One Tructor Mahindra Arjun Ultra having registration number WB/63/A/5704 loaded with illegal river bed materials. I, ASI Biplab Kr Das of Pradhan Nagar PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against the driver and owner of the above mentioned seized vehicle having registration numbers WB/63/A/5704 to the effect that on today (04.06.2025) at 08.20 hrs, I received a specific source information that illegal mining of river bed materials is going on at Military Ghat, Mahananda river bed under Pradhan Nagar Police Station, Dist. Darjeeling and the owner and driver loaded such illegal river beds materials illegally in his vehicle with a view to sale the same to their design customers for their illegal gain. Accordingly, I diarized the matter in PS General Diary vide Pradhan Nagar PS GDE No. 180 dated 04.06.2025 and informed the matter to you and as per your kind order and direction myself along with officers and force left for Mahananda river bed (Military Ghat) to verify the veracity of the information by Govt. Vehicle.

At around 08.55 hrs we reached at Military Ghat and from a considerable distance noticed that one tracktor was coming from Mahananda river bed. We proceding towards the said tractor to verify but seeing the police van the driver and owner of the said tractor came down the vehicle and started to flee away by crossing Mahananda river. We tried to apprehended them but in vain. During physical verification it is found the vehicle is loaded with river bed materials. I searched the owner/driver of the above mentioned trucktor but nobody come forward to claim the vehicle as their own. During enquiry, it could be revealed that driver and owner jointly mines river bed materials from Mahananda river by illegal means and loaded the same in their vehicle to sale the same to their design customers for their illegal gain. Accordingly, I seized the above mentioned tractor loaded with illegal river bed materials under proper seizure list from the spot under section 106 BNSS. The entire process of search and seizure was made under the coverage of videography in between 09.15 hrs to 09.45 hrs as per norms of BNSS and brought to Pradhan Nagar PS/SPC for further investigation.

Under the above circumstances, I, pray before you that a specific case under proper section of law may kindly be started against the owner and driver of vehicle having registration number WB/63/A/5704 and arrange for its investigation.
