In producing herewith following seized articles as per seizure list viz :- (i) One Tata truck having registration number WB/73/C/4738, loaded with illegally mined river bed materials, (ii) One truck having registration number WB/76/2114 loaded with illegally mined river bed materials, (iii) One truck having registration number WB/73/3321 loaded with illegally mined river bed materials, (iv) One truck having registration number WB/78/1227, loaded with illegally mined river bed materials (v) One truck having registration number WB/73/A/2486 loaded with illegally mined river bed materials and (vi) 08 (eight) numbers of shovels.

I, SI Bandhan Roy of Pradhan Nagar PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against the drivers and owners of the above mentioned seized vehicles having registration numbers viz:- (i) WB/73/C/4738, (ii) WB/76/2114, (iii) WB/73/3321, (iv) WB/78/1227 and (v) WB/73/A/2486 to the effect that today (04.06.2025) at 08.20 hrs, I received a specific source input regarding illegal mining activity being carried out at the Mahananda river bed near Military Ghat, Natun Bazar under Pradhan Nagar PS, Dist. Darjeeling. It was reported that river bed materials were being illegally excavated and loaded onto the vehicles for their illigal gain. Upon receipt of the information, I made a General Diary entry vide Pradhan Nagar PS GDE No. 180 dated 04.06.2025 and informed to you. As per your kind order and direction, I proceeded with a team in a Govt. vehicle to verify the veracity of the information.

On the way the source informed that the vehicles are loading illegally mined river bed materials at the Mahananda river bed near Military Ghat, Natun Bazar under Pradhan Nagar PS, Dist. Darjeeling. At around 08:45 hrs on arrival at Military Ghat, the said vehicles were spotted. Upon noticing the police presence, the drivers and owners attempted to flee but abandoned the vehicles on ground of Military Ghat and escaped on foot. Despite efforts, the drivers and owners could not be apprehended. Upon physical verification, the vehicles having registration numbers (i) WB/73/C/4738, (ii) WB/76/2114, (iii) WB/73/3321, (iv) WB/78/1227 and (v) WB/73/A/2486 were found to be loaded with illegally mined river bed materials. Enquiries regarding the owners and drivers yielded no leads as all were found to be absconding. Accordingly a proper seizure was carried out viz: :- (i) One Tata truck having registration number WB/73/C/4738, loaded with illegally mined river bed materials, (ii) One truck having registration number WB/76/2114 loaded with illegally mined river bed materials, (iii) One truck having registration number WB/73/3321 loaded with illegally mined river bed materials, (iv) One truck having registration number WB/78/1227, loaded with illegally mined river bed materials (v) One truck having registration number WB/73/A/2486 loaded with illegally mined river bed materials and (vi) 08 (eight) numbers of shovels at the site in between 09:30 hrs to 10.45 hrs under video surveillance under section 106 BNSS.

Under the above circumstances, I pray before you that a case be registered under appropriate sections of law against the drivers and owners of the vehicles having registration numbers (i) WB/73/C/4738, (ii) WB/76/2114, (iii) WB/73/3321, (iv) WB/78/1227 and (v) WB/73/A/2486 involved in illegal mining, and arrange for its investigation.
