With due respect, I Passangmit Lepcha (24 yrs) Daughter of Sona Tshering Lepcha permanent resident of Yangmakum, Tik Busty, PS+Dist.- Kalimpong like to inform you that on 04.06.25 at around 12.00 hrs I returned from Bangalore by flight and arrived at Bagdogra Airport. After that, I went to the residence of my friend namely Nurpandi Lepcha at Pradhan Nagar. On the same day at around 4.PM I was going to a hotel of Siliguri Junction by a Toto and while reached at near Heritage Hotel suddenly two unknown persons came from back side by a red and black colour Scooty and forcefully snatched my handbag and fled the scene. The hand bag contained the following items.

- i) Passport (R6930266)
- ii) Wallet containing my voter ID Card (No Cash)
- iii) My company ID Card and Airport entry permit.
- iv) Make up Box
- v) Phone Charger and earpods
- vi) Power Bank

I tried to follow the culprits but was unable to catch them as they fled away from the spot by their scooty in high speed. I request you to kindly register an FIR and take necessary legal action to trace the culprits and recover my stolen belongings. I am ready to co operate fully in the investigation.
