Respected Sir,

I, Smt. Sima Bhattacharjee, wife of Arun Bhattacharjee, aged about 50 years, residing at Arabindapally, near Samar Biri Factory, Ward No. 22, Siliguri Municipal Corporation, P.O. Rabindra Sarani, P.S. Siliguri, District – Darjeeling, West Bengal, Pin – 734006, am writing this complaint in regard to a horrifying and life-threatening incident that occurred at my residence today, on 04.06.2025 at around 4:45 PM.

Today, I had called a technician named Subrata Das to install a CCTV camera on our flat premises for safety and security purposes. However, to my utter shock, a group of neighbours began protesting against the installation of the CCTV camera. They started gathering near our gate and behaving in a threatening manner.

The following persons were involved in the incident:(1) Jayanta Dutta, s/o Jiban Kishore Dutta (2) Tumpa Dutta, w/o Jayanta Dutta (3) Nilay Goswami, s/o unknown (4) Prasanta Dutta,s/o Jiban Kishore Dutta (5) Mampi Chakraborty d/o Nilay Goswami (6) and one more daughter of Nilay Goswami, and few other unknown.

While the technician was doing his work, Jayanta Dutta and Nilay Goswami suddenly began to mercilessly assault the technician. Seeing him being attacked, my husband and I came out of our flat to stop the violence. However, sensing their violent intentions and anger, we immediately returned to our flat for safety.

But the situation escalated rapidly. The above-named persons gathered outside our main gate, shouting filthy abuses, banging the doors, and

threatening to kill us. Since the gate was open due to the technician's work, they forcefully entered our flat without permission.

When I asked them to stop and leave, Jayanta Dutta and Nilay Goswami grabbed me violently, hurled verbal abuses, and began physically assaulting me in the most brutal and shameless manner. They touched my private parts, tore my yellow nightgown, and attempted to rape me. They shouted, "Ajkebura-budhikei mere felbo". They also snatched my mobile phone, model no. Nokia 105, phone number 70633-71221, and took away my gold chain and gold earring.

Then, all the named persons dragged me out of my house by pulling my hair, threw me onto the ground, and began beating me mercilessly with the intension to kill me. I was kicked repeatedly in my private parts, hit with wooden sticks (battam), and beaten with shoes. They hit my head, chest, and legs, causing unbearable pain. I screamed for help, but no one came forward out of fear. I eventually fainted due to the brutal beating.

When my husband, who is also aged, tried to save me, they brutally assaulted him as well, causing serious injuries. I also tried to call my son, but they snatched my mobile phone and threatened us with dire consequences if we told anyone.

Sir, these people not only assaulted and molested me, but they also tried to kill me in broad daylight, inside my own home. The attack was clearly preplanned. After the incident, they even locked us inside our home and stopped us from going out to get medical treatment which is very inhumane in nature.

Somehow, with great difficulty, I managed to escape. I am in severe physical pain, and both my husband and I are under deep mental trauma and fear for our lives.

I humbly request you to take immediate and strong action against all the accused persons. I am extremely afraid that they may now try to attack and harm my son as well. Their behaviour shows they are capable of any violence. Please take strict action against them at the earliest to ensure our safety and prevent any further attack on my family.
