Dear Sir,

I, Sri Abhishek Roy, S/O Jagadish Ch Roy, Station Manager, Customer Care Centre Matigara, WBSEDCL, P.S Matigara do hereby lodge this complaint empowered by Electricity ACT 2003 (amendment act 2007) to the effect that Sushil Kumar Agarwala S/O Lt Laxmi Narayan Agarwala at Beekay NEO Building 4<sup>th</sup> Floor, F5 block, P.O. MATIGARA, Darjeeling, he has committed use of electricity illegally under section 135 (1) (a) of electricity Act 2003.

On dated 05.06.2025 at 13.30 hr I along with accompanying WBSEDCL team viz. 1) Lakhan Tamang, JE GR-I of Matigara CCC, 2) Sanjoy Ram of Matigara CCC, 3) Patilal Rai of Matigara CCC have entered the premise of Sushil Kumar Agarwala. During inspection it has been found that a meter bearing serial number 24190123, manufactured by Schneider Electric India Pvt. Ltd., was found connected directly to the LT busbar of BEEKAY NEO Building. The said meter does not belong to WBSEDCL and has no linkage to any WBSEDCL-authorized connection. From the aforementioned LT busbar, an electrical connection has been extended to F5 Block (4th Floor) of the building. The assessed load being drawn through this unauthorised connection is 39.57 KVA under Commercial Category.

The findings are incorporated in the inspection report prepared at site. As the energy consumption through this connection is not recorded in WBSEDCL's system and no authorised service connection exists, this act amounts to illegal tapping of electricity directly from the LT kiosk busbar.

Hence prepare an inspection memo by mentioning all minute details, as observed and also seized the meter in question after preparing the proper serial list duly signed by witnesses and representative of the premise owner. Supply copies of required documents to the representative for future reference. Remove the meter from the place after observing all technical formalities. The inspection team left the said premises at 15.10 hrs on date. It is assumed that the illegal usage of energy is going from 01.03.2025.

So it is requested that a case under section 135 (1) (a) of Electricity Act may please be registered against Sushil Kumar Agarwala S/O Lt Laxmi Narayan Agarwala and arrange for its investigation.
