I, Smt. Durga Chhetri, W/o Late Pran Chhetri, aged about 63 years, a widow and a senior citizen residing at Shastrinagar, Ward No. 41 of S.M.C., P.O Sevoke Road, P.S. Bhaktinagar, Dist. Jalpaiguri, West Bengal - 734001, would like to inform you that today i.e., 04/06/2025, in evening around 05:25 pm while I was at home, my tenant came to me for giving a monthly rent at that time my daughter Sarina Chhetri and her daughter Ashwini Chhetri came there and started shouting and abusing me, and even they tried to grab my neck forcefully and tried to kill me and even pushed me back so hard into the floor and started kicking me with leg and wooden stick, where I got injured in back side of head and in my body, elbow and back side of waist, which made me breathless.

And at that time my younger daughter Subani Chhetri came there for visiting me as my health condition is not well and she helped me to stood up from the floor, but at that time again Sarina Chhetri and her daughter Ashwini Chhetri again started to kick me and my daughter Subani Chhetri and she even broke the phone of my daughter Subani Chhetri.

The above named persons have continues to their rude and ill treatment towards me and are making me suffer from various mental and physical torture every now and then. Their actions and conduct have amounted to threat to my life.

Therefore, I request you to register this FIR and take immediate action in this regard and investigate the matter thoroughly for this act. I urge you to take strict action against the above named persons and bring justice.
