I, Sarina Chhetri, Daughter of Late Pran Chhetri, Wife of Sri Mihir Anand, resident of 1B Radha Apartment, Gandhi Nagar, Lower Bhanu Nagar, Ward No.43 of Siliguri Municipal Corporation, Siliguri, Post Office-Sevoke Road, Police Station-Bhaktinagar, District-Jalpaiguri, PIN-734001 would like to inform you that I am the owner of a G+2 storied building (except a flat therein) situated at Near Radha Krishna Complex, Shashtri Nagar, Ward No. 41 of Siliguri Municipal Corporation, Sevoke Road, Siliguri, Post Office- Sevoke Road, Police Station- Bhaktinagar, District-Jalpaiguri, PIN-734001.

Past few days I was at my matrimonial house and today at around 5.00 pm when I visited my aforesaid building with my daughter. My mother Smt Durga Chhetri, Wife of Late Pran Chhetri and my sister Subani Chhetri (Mobile:9933182752 / 8820590215), Wife of Sri Suraj Chhetri, Daughter of Late Pran Chhetri became very aggressive and furious upon seeing us. When I entered the building I found that my cameras have been damaged and all the wires have been severed. Furthermore, both the aforesaid duo have broke open the lock of one of my flat and thereafter let out the same on rent to a third person who is not known to me and without my knowledge. My mother and my sister used abusive words on me and my daughter and further also used hands upon my daughter and assaulted my minor daughter and tore her clothes also.

I kindly request you to take immediate action by registering this complaint as an FIR in accordance with the appropriate provisions of criminal law.
