I "Solanki Maity" daughter of Sri Biswanath Maity, aged about 27 years, Hindu by faith, Housewife by occupation, resident of South Deshbandu Para, Pipe Line, Ward No. 30, Post Office Siliguri and Police Station Siliguri, District Darjeeling, would like to inform you that Rina Das wife of Sri Atanu Das, aged about 50 years, resident of South Deshbandu Para, Pipe Line, Ward No. 30, Post Office Siliguri and Police Station Siliguri, District Darjeeling (Mobile No.- 9434494329) my maternal Aunt and Riyon Das son of Sri Atanu Das, aged about 20 years, resident of South Deshbandu Para, Pipe Line, Ward No. 30, Post Office Siliguri and Police Station Siliguri, District Darjeeling (Mobile No.-8967556980) my cousin brother, both out of jealousy were disturbing the peace and harmony of my family especially of my brother's (Rohan Maity) marital life and I protested against the conspiracy led out by them. All of a sudden both my aunt (Rina Das) and my cousin brother (Riyon Das came to my resident at about 11:20 p.m. on 30.05.2025 and started assaulting me with fist and blow & kicked me and severed my dress due to which I suffered severe bodily injury and pain and damaged the furnitures' and fixtures of my house and kicked the doors and used abusive slang language towards me and my family members. Moreover, both my aunt (Rina Das) and cousin brother (Riyon Das) told me that I have no right to stay in my parent's house as I am "Divorcee" and I must get out from my parental house. After this said incident I am suffering from mental trauma, anxiety and bodily pain but my aunt (Rina Das) and my cousin brother (Riyon Das) both are threatening me and my family members and most significantly my cousin brother (Riyon Das) is wandering in the road out of my house in search of me with sharp deadly weapon. (sharp knife, Daa) and is shouting out of my house and saying that if he sees me out of my house then he will murder me with Daa and also he (Riyon Das) is whistling out my house that if I step out of my house then I have to face dire consequences

I am passing my days in acute state of fear and danger of life and I therefore request you to kindly take necessary action against my aunt (Rina Das) and cousin brother (Riyon Das).
