write you this F.I.R. to bring you notice that Dipu Kanti

P.S. - Pradhan Nagar, Siliguri, physically assaulted me with
~~knife~~ ^{knife} and continuously threatened me to kill me and my
family.

I am the bazar ~~committee~~ committee member of
Debidanga Bazar, ~~Debidanga~~ on 6/6/25 at around 10:00 pm
I was ~~in~~ at the Debidanga Bazar that time the
above named Dipu Kanti approached me and started
using filthy languages and forcefully tried to snatch money
from me ~~upon~~ ^{on my right hand} stopping him he suddenly hit me with
knife, ~~by~~ ^{seeing the incident} the other committee
member Ramesh Singh approached me and rescue me
from his hand and immediately took me to the
Siliguri District Hospital for medical attention, the
above named Dipu Kanti followed me to the hospital
and threatened me ~~that~~ ^{that} he will again hit me with knife
and kill me whenever he ~~get~~ ^{get} the chance. The doctor
put 2 stitches on my wound of my right hand.

Due to the incident I am in a great fear of
my life as found no other way came before your office to
take immediate legal action against ~~the~~ Dipu Kanti.
