① That today i.e. on 08/6/25 when my husband
and his friend namely Swajit Sen s/o -
Ranjit Sen, r/o. East Baghatin Colony
PO & P. Pradhan Nagar, Dist. Dargjeeling
were busy in the town & travels office opening
ceremony at that time ① Vijendra Kapoor
s/o. Bansi Ram Kapoor, r/o. Gate bazar,
BRI Road, PO & P. Pradhan Nagar ② Chhotu
s/o. not known ③ Pramod Kanti s/o. Not
known, r/o. Dharamnagar Road, PO & P. Pradhan
Nagar, Dist. Dargjeeling ④ Uday Narayan
Mishra s/o. Anshu Bihari Mishra, r/o. I
Diesel colony, Pradhan Nagar, Dist. Dargjeeling
along with 15/20 persons at about 01:00 Pm
forcibly entered in my husband's office
and started threatening and abusing Swajit
Sen, that as to why he took my husband as

- his business partner. Seeing this my husband and his friend protested, ^{they} they became furious thereafter the above named culprits and their men after closing the shutter started assaulted my husband, they brutally assaulted my husband. my husband got severe injury in his body, the above named culprits hit my husband's with Iron rod, causing blood was oozing from the head of my husband.
- Those culprits with intention to murder my husband tied electric wire in his neck and started strangulated to kill him but in the meantime police came and local people open the shutter and save my husband.

If police did not come within time and local people had not opened the shutter and rescued my husband they would definitely kill my husband.

Seeing the condition local people took my husband and admitted him in Srigweri C. D. Hospital, my husband is under doctor's observation.

I, therefore, request you to kindly take necessary legal action against the aforesaid culprits.
