With due respect and humble submission I, A.S.I Amar Raj Subba of Pradhannagar PS SPC, do here by lodged this written complaint against the following accused persons viz (i) Vijendra Kapoor @ Masum S/o Basti Ram Kapoor ii) Uday Narayan Mishra S/o Awadh Bihari Mishra iii) Surendar Kapoor @ Chattu S/o Ram Basti Kapoor iv) Promod Kamti and 15/20 others to the effect that today i.e. on 08/06/2025 at around 14:20 hrs., I along with Const. 1503 Bidhan Roy Pramanik Const. 1198 Rajesh Kumar had been to Roy Ranjan Tour and Travels, Hill cart road opposite Hotel Heritage under Pradhan Nagar PS for investigation of Pradhannagar PS Case No. 396/25 dated 08/06/2025 u/s 329(3)/117(2)/109/351(2)(3)/3(5) of BNS and found that the victim of the case namely Pradip Sarkar was lying in injured condition on the floor of the office. When I was arranging to shift him to Hospital at that time above noted persons along with others started abusing Police team and obstructed me and my force from discharging lawful duty. When I tried to convince them, all the above noted accd persons assaulted me and other force physically. As a result I fell down and got injured. I immediately informed the matter to you over telephone for providing assistance. Then SI Bandhan Roy with force arrived there and controlled the situation. Subsequently I along with other force got treated at Matigara B.P.H.C. Copy of treatment slips are attached here with.

Therefore I, pray before your kind honour that a specific case may kindly be started against the above noted accd, persons under appropriate section of Law for obstructing and assaulting me and my force in time of discharging bona fide and lawful Govt, duties.
