I Sora Singh Kherwar, w/o. Smt. Ramech Singh.

R/o:- Devidanga Bazar, do hereby would like to state that
one Deepak Kamti along with Jiten Kamti came and entered
to my house at around 8:30 P.M in search of my husband
with a firearms but fortunately he was not at home and
threatened me knowing that I am pregnant..with the
gun and set open fire at the premises around 3 rounds
They further kicked my womb and said "Kala Ka Santan
Ko bhai mardega" and that they will kill all the family
members in a span of a week. And they started saying
"Kala tu Kala hai nikal" "Nahi to tera biwi ko mardega."
thereafter the intervention of neighbours was made and as
such they fled away. Deepak Kamti happens to be the habitual
offender and is a wanted criminal and there is every possibility
that they will kill all our family members, if left open. It is
pertinent to mention here that the same person had stabbed
my husband knife in the year 2015 -to which a case is
pending against him. They are very dangerous in nature
and they do not fear anyone.

Therefore I request you to kindly take the necessary
action against the said criminals.
