Sub: Lodging of FIR against Mr. Pravin Kumar Agarwal for blocking access to godown in violation of court order.


Respected Sir,

I, Sri Bajranglal Agarwal, S/o Lt. Gobind Ram Agarwal, resident of 2nd Mile, Sevoke Road, Siliguri-734001, P.O. Sevoke Road, P.S. Bhatinagar in the District of Jalpaiguri being the KARTA of Bajranglal Agarwal & Sons (HUF), would like to state as follows:

- 1. That I would like to file a complaint against one Pravin Kumar Agarwal, S/o Lt Laxminarayan Agarwal, Resident of 2nd Mile, Sevoke Road, Siliguri-734001, P.O. Sevoke Road, P.S. Bhatinagar in the District of Jalpaiguri.
- 2. That the abovenamed Pravin Kumar Agarwal is trying to block access to our godown situated at Opp. Bajaj Showroom, Behind Tanishq, 2nd Mile, Sevoke Road, Siliguri – 734001, by installing an iron gate.
- 3. That this act is in clear violation of the status quo order passed by the Court of the Ld. Civil Judge (Junior Division) in Misc Case (Pre-emption) No. 80 of 2024 by Order No. 08 dated 06.02.2025.
- 4. That the court had explicitly directed that no party shall alter the existing condition of the land. The extract from the order is mentioned below:

"the parties hereunder shall maintain status quo as regards their respective possession and nature and character of the case property this"

- 5. That despite the said order, the abovenamed Pravin Kumar Agarwal has taken the law into his own hands by obstructing the entry to the godown by installing permanent structure such as iron gate.
- 6. That the godown has no other entry points and will be land locked if the iron gate is installed.
- 7. That I have enclosed a copy of the Order No. 08 dated 06/02/2025, herein.



I request you to kindly register an FIR and take immediate action to prevent such construction, restore access to godown and uphold the dignity of court's order.
