Complaint against the driver of an unregistered Toto Vehicle.

With utmost respect, I SI Tenzing Nubu Bhutia of Bhaktinagar Traffic Guard Respected Sir, would like lodge a written complaint that on 07/06/2025 at about 11:00 hours 01 (one) Toto Vehicle found plying on NH 10 near Checkpost More, PS- Bhaktinagar which was blocking the free flow of traffic and causing hindrance to the public in general and violating the Govt. Order No. 2996 (2)-WT/3M-56/13 (Pt. II), Dated: 26/07/2019 of Transport Department, Govt. of West Bengal.

I along with the force namely C/ 961 Kamal Chandra Mallick and CV/654 Rabi Roy stopped the Toto Vehicle along with the driver and on being asked the Toto driver disclosed his name as Rahul Prasad, S/O Amarnath Prasad, resident of Samar Nagar, Bartala, Champasari, Siliguri PS- Pradhan Nagar Dist- Darjeeling.

Subsequently, the Toto driver was asked to produce the relevant documents for plying on NH 10 but he failed to do so and during the process, while trying to detain the Toto, the said Toto driver did not comply with my lawful instructions and behaved in rude and unruly manner towards the on duty police personnel. Moreover, he started scuffling with C/ 961 Kamal Chandra Mallick and damaged 01 (one) Manpack (Govt. property) bearing Serial No- 749TQA4391 and immediately called for back-up from Bhaktinagar PS and soon after that RT Mobile K-37 Van of Bhaktinagar PS reached the spot and the said Toto driver along with the Toto was handed over to the Police team of Bhaktinagar PS.

Considering the gravity of the above fact and circumstances, I request you to kindly look into the matter of the Toto Driver namely Rahul Prasad, s/o Amarnath Prasad who was causing hindrance to the public in general, disrupting the free flow of traffic and violating the Govt. Order regarding plying of Totos as well as initiate a specific case against the said Toto Driver for his disorderly behaviour, causing disruption in performing Govt. duty and damaging of a Govt. property under a proper section of law.

Your immediate action in this regard will be highly appreciated.
