Sir,

I Shri Amitav Dutta, son of Lt. Amulya Dutta resident Hakimpara, P.O. and P.S. Siliguri, Darjeeling, would like to inform you that I am the recorded as well as registered owner of land ^{in possession} measuring 95 Decimals, in L.R Khatian No: 84 and Plot No 39 & 44, Mouza: Baragharia, behind Pragati college, Lutiya Jote, under Patharghata Gram Panchayat, P.S: Matigara, Darjeeling. since march 2025 whenever I or my caretaker namely Shri Dulal Kanti Kar visited upon my abovementioned land for measurement and construction work for the boundary of my land or any other purpose, some anti-social, land grabber/land mafia's namely:

1. Santosh oraon S/o Bhद्रu oraon. R/o Lutiya Jote, Baragharia, P.S: Matigara
2. Pradip oraon S/o Khaduya oraon R/o Lutiya Jote, Baragharia, P.S: Matigara
3. Kishnu @Krishna oraon S/o Sukra oraon. R/o Lutiya Jote, Baragharia, P.S: Matigara
4. Bikramoraon S/o Mangza oraon.. R/o Panchanai Busty, Champasari, P.S: Pradhannagar,

several times forcefully by putting me as well as my caretaker in fear and threat creating/created problem in measurement and work on the said land and always demanded Rs 20,00,000/- (Rupees Twenty Lakh only)/- as local gunda tax otherwise they will continue to create problems. In this regard on 7/05/2025 I have lodge a complain and recently on 24/05/2025, at about 11:00 Am when my caretaker with labour reached upon the aforesaid land then the aforesaid persons on 24/05/2025 with some female members namely: 1) Santosh oraon S/o Bhद्रu oraon. R/o Lutiya Jote, Baragharia, P.S: Matigara. 2) Pradip oraon S/o Khaduya oraon R/o Lutiya Jote, Baragharia, P.S: Matigara. 3) Kishnu @Krishna oraon S/o Sukra oraon. R/o Lutiya Jote, Baragharia, P.S: Matigara.

4) Bikramoraon S/o Mangza oraon.. R/o Panchanai Busty, Champasari, P.S: Pradhannagar, put forward intentionally some female members namely: 5) Anjana Oraon W/o Pradip Oraon, 6) Meena Oraon W/o Mangra Oraon, 7) Anita Oraon D/o Bhadr Oraon all are resident of Baragharia, Lutiya Jote P.S: Matigara, Dist: Darjeeling, taking the advantage of being women and their community all the female members came on my land as mentioned above and threaten me and my caretaker that if I will not give /paid them Rs. 50,00,000/- (Rupees Fifty Lakhs only) or 50% amount of market value of the aforesaid land till then they will neither allow me to sold the land to anyone nor they will allow me to enter easily on my aforesaid land and

till the realization /obtaining the gunda tax like land mafias they will continue to create obstruction on my said land and even threaten my caretaker that they are knowing fully well and intentionally put forward their females i.e. Womens/ Girls to success in their purpose and also threaten if their demand will not fulfill then they are taking the advantage of their females members/girls/women may lodge false complain against me or my caretaker and also advise me if I will paid 50% amount of market value of the aforesaid land to them then there will be no problem and no one will come to create any problem and again on 01/06/2025 at about 11:00 Am allthe above male and female members again do the same act when my caretaker Dulal Kanti Kar went on my said land with labour then all of them looted away the bamboos and other materials for construction work and again demanded Rs. 50,00,000/- (Rupees Fifty Lakhs only) or 50% amount of market value of the aforesaid land and when my caretaker informed them that the landlord is in financial crisis that's why going to sold the land for which construction of boundary to some extent is required as per demand of intending purchaser then they replied that if I will going to sold the land then I shall have to leave the matter of sale of land to the person as per their choice as well as per the price fixed by them.

It is to be noted here in this regard I have already lodge a complaint on 7/05/2025 and today also they have threaten us that if I or any of my caretaker or labour will enter into the land then they will taking the advantage of their female members/Community(S.T) will lodge a false complaint giving false allegation regarding the female members against me or my caretaker shri Dulal Kanti Kar or any of my members/labours.

So, I therefore requesting you to kindly provide me the police protection where I am the legal owner with registered deed/recorded owner of the aforesaid land and the persons and their female members who are disturbing me have no document in respect of abovementioned land and inspite of call as well as informed by the Matigara police station they have/had never came or visited the Matigara Police Station in this matter and till today they are demanding their illegal demand by way of extortion and threatening to lodge a false complain using their female members and the females members members are also threatened in this manner.

So, I therefore requesting you to kindly enquire into the matter and provide me the police protection to work on my land at the time when I or my caretaker will enter on the said land as per date and time informed by you and also enquire into the matter.
