Dear Sir,

This is to bring to your kind notice that Auspicious Aqua Pure Pvt. Ltd., had entered into a joint venture with HIMUL, in August, 2006, for manufacturing packaged drinking water, named and styled as "Himul Jal". And as per the said agreement Auspicious Aqua Pure (P) Ltd. Was given a space area of about 10,000 Sq.Ft, shed where we had started manufacturing packaged drinking water.

From January, 2012, however the plant remained inoperative due to unavoidable circumstances.

But however, the plant and machineries remained in the said premises due non-resolution of some outstanding issues with HIMUL. The machineries inside the shed was quite valuable roughly about Rs.1 crore 25 lakhs. And I had appointed one guard, viz. Sri Tika Prasad Chettri, son of Dedi Bahadur Chettri, permanent resident of Nepania West, Naxalbari, Bara Chenga.

I had lastly gone to the plant in November, 2024, to get a shutter repaired and I had at the relevant time inspected the said pant and machineries along with my son and the aforesaid guard and his sub-ordinate, Baburam Das, s/o Bhugen Das, permanent resident of Dariagachh Village, P.O. Narayanpur, P.S. Chopra, Dr. U.Dinajpur. Photographs had been taken on the said date of the machineries in the plant on that date.

Yesterday, at about 4.15 pm, I came to know that there has been a theft in the plant premises. I immediately sent my son Manish Goyal, who inspected the premises in front of the aforementioned two guards.

Under the circumstances, I earnestly request you to kindly investigate into the matter, and take necessary action as per law.
