I myself Sanchita Saha Ghosh, daughter of Mr. Sanjib Saha residing at Kalamjole, Post-Sushruta Nagar, P.S-Matigara, Dt-Darjeeling, Pin-734012.

I got married on 22 January 2022 to Sourav Ghosh son of Mr. Barun Ghosh @ Balaram Ghosh residing at 53.B.M Saha Road, Nandankanan, P.O-Hindmotor, P.S-Utharpara, Dt-Hoogly Pin-712233.

Since, I got married, within one month I learned that my Husband had a love affair with a girl. After realising, they started mental and domestic torture to me. On 2023, I conceived a baby on Month of January. On the month of March, my In-laws didn't took care of me instead again they started torturing me mentally. Then my father recovered me from there and I came back to my father's house since 2 years.

My In-laws gave a Petition against me from Serampore civil court. And against this we took a stay order from Calcutta High Court.

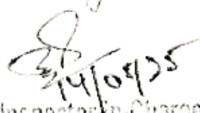

And, on April 2023, he started video calling through whatsapp and asked me to show my intimate bodyparts. Without my knowledge he took many screenshots and recorded the video ^{and sent to me}. Facebook ID(2): (Ghose Sanchita Sunny) <http://www.facebook.com/profile.php?id=61550328020018>. He is threatening me that he will show all the intimate pictures to my relatives through facebook.

Due to these harassment and blackmailing, I and my family are feeling ashamed and we are unable to show our face in society and unable to cope with people of our society.

So, I request you Sir to immediately take a strict action and strict investigation against this mentioned blackmail incident on the application so that I can get an appropriate justice.
