I, SI Suraj Kr Chhetri (51 yrs) S/O Lt. Bhim Kr Chhetri, of the Cyber Crime PS, Siliguri Police Commissionerate, hereby lodge a written complaint stating that today, on 02.06.2025 at approximately 15:25 hrs, while I was engaged in social media monitoring duty at Cyber Crime PS, Siliguri, I found one Facebook online new portal namely "Siliguri Network Time" posted communal provocative posts along with comments "सिलीगुड़ी है या बांग्लादेश? हिंदुओं पर पुलिस ने बेरहमी से अत्याचार किया, लाठी चार्ज किया, बंध के दौरान रोंगटे खड़े कर देंगे, ऐ वीडियो।" In relation to this issue, many hateful comments are circulating on social media, inciting enmity between two communities based on religious grounds and actions that are prejudicial to the maintenance of harmony. The content of these posts poses a severe threat to communal harmony of the area which was done with criminal a conspiracy to abetment of violence and unrest which could lead to a breakdown of law and order in an around the jurisdiction of Siliguri, Jalpaiguri and adjacent area. Hence, I pray that you kindly register an FIR against the user of the social media profile under proper section of law and take necessary action to remove the offending material from the respective social media platform, and conduct an investigation into this matter.
