Sir,

I, SI Bikash Kisku (52 yrs), S/O Lt. Gopal Kisku, of the Cyber Crime PS, Siliguri Police Commissionerate, hereby lodge a written complaint stating that today, on 02.06.2025, at approximately 16:15 hrs, while I was engaged in social media monitoring duty at Cyber Crime PS, Siliguri, I found frequent communal provocative comments and incident on 30.05.2025 a vehicle was intercepted by local people at Balasan Bridge, Matigara, and set on fire for allegedly illegally carrying beef, driven by a Muslim individual. Simultaneously another post about incident where a group of people ransacked a residential house belonging to a Hindu family, physically assaulted family members, and issued threats. Both post circulating on social media platforms (Facebook) by the many online news portal i.e. The News Box, SK Live, UJ News and other facebook user. Due to the circulation of such news in media has violated the moral responsibility and legal obligation of the press media. In relation to this issue, many hateful comments and video speeches are circulating on social media and abetment to commit communal violence between two communities based on religious grounds. It has the potential to provoke violence and unrest among communities within the local jurisdiction of Siliguri sub division.

Under the above circumstances, I pray that you kindly register an FIR against the user of the social media profile under proper section of law and take necessary action to remove the offending material from the respective social media platform, and conduct an investigation into this matter.
