I, SI Suraj Kr Chhetri (51 yrs) S/O Lt. Bhim Kr Chhetri of the Cyber Crime PS, Siliguri Police Commissionerate, hereby lodge a written complaint stating that today, on 07.06.2025, at approximately 20:13 hrs, while I was engaged in social media monitoring duty at Cyber Crime PS, Siliguri regarding the Eid-ul-Zuha (Bakrid) festival, I found frequent communal provocative comments/reporting by the Reporter of The News Box, over the incident of some animals bone are lying beside the road at Salugara Post Office gali, SMC Ward No. 42. Due to the circulation of such news in media has violated the moral responsibility and legal obligation of the press media. In relation to this issue, many hateful comments and video speeches are circulating on social media and abetment to commit communal violence. It has the potential to provoke violence and unrest among communities within the local jurisdiction of Salugara and surrounding areas.

Under the above circumstances, I pray that you kindly register an FIR against the Facebook new portal "The New Box" under proper section of law and take necessary action to remove the offending material from the respective social media platform, and conduct an investigation into this matter.
