## Subject: First Information Report

I the undersigned would like to draw your kind attention towards the fact that I got married with one Sri Goutam Dey, Son of Late Manmohan Dey, resident of South Shanti Nagar, Binoy More, Pipe Line, Dabgram II, Police Station: Bhaktinagar, Post Office: Rabindrasarani, District: Jalpaiguri, Pin Code: 734006 having mobile number: 81014-13679 on 26.01.1996 in Kalibari situated at South Colony, Siliguri as per Hindu rites and customs. That from 22.03.2025 my husband started torturing me both mentally and physically every day on petty issues. That the ill-treatment increased and the abuse became severe with each passing day. That even after all the torture I kept quiet in hope of having a happy, healthy and balanced family, and tried to satisfy all the demands of my husband but to the contrary he used to yell at me using filthy language and physically assaulted me. Thereafter whenever I have requested him to overcome his behavior as the same was affecting the health of our daughter, he did not pay any heed to it and on contrary, in the moment of extreme aggression; he has assaulted me severally.

That today i.e., on 07.06.2025 at around 8:30-8:45p.m. in the evening my husband started abusing me and I was thrashed and

beaten mercilessly and was badly injured, even after seeing that my husband started pulling me by my hair and dragged me from one room to another and strangulated my throat with an intention to kill me. Thereafter I got fainted in my room and when I regained consciousness, I contacted my parental home and informed them about the same and left my matrimonial house.

Under these circumstances I would request you take appropriate steps the abovementioned person under the suitable provisions of law. At present I am passing through immense agony and my life is at stake due to aforesaid acts of my husband.
