Sir,

With due respect and humble submission, I SI Mrityunjoy Roy of Matigara P.S, SPC do hereby lodge this written complaint to the effect that today on 09.06.2025 I was deputed to perform Special Raid duty along with force vide Matigara P.S.M.C.C. No. 1801 /2025, Dated - 09.06.2025 & Matigara P.S. GDE No. 467, Dated - 09.06.2025. At about 19:10 hrs, in course of said Van duty I received source information that one vehicle Mini Dumper bearing Reg. No. WB - 73 F 9168 loaded with river bed materials is standing in front of BDO office, Shivmandir under PS-Matigara which was procured clandestinely. On receipt of such information, I informed the matter to I/C Matigara PS over phone and as per his kind direction myself along with force rushed to the spot and found one vehicle Mini Dumper bearing Reg. No. WB - 73 F 9168 loaded with river bed materials standing at Shivmandir in front of BDO Office. On demand the driver of the vehicle could not produce any valid documents in support of said load. It is crystal clear that the driver/owner of the vehicle Mini Dumper bearing Reg. No. WB - 73 F 9168 procured the loaded river bed materials from somewhere clandestinely and was proceeding to sale the same to his designated customer for his wrongful gain.

Finding no other alternatives, I seized the vehicle Mini Dumper bearing Reg. No. WB - 73 F 9168 loaded with river bed materials under proper Seizure List under coverage of Videography also arrested the driver namely Dipu Barman (26 years), S/O Niranjan Barman of Binay Nagar, Chaitanyapur, PO- New Rangia, PS- Matigara, Dist- Darjeeling and brought the seized vehicle at P.S. The seizure was made in between 19:25 hrs to 19:40 hrs.

I therefore pray before you that a specific case under proper section of Law may kindly be started against the accused driver namely Dipu Barman (26 years), S/O Niranjan Barman of Binay Nagar, Chaitanyapur, PO- New Rangia, PS- Matigara, Dist- Darjeeling and arrange for its investigation.
