Sir,

With due respect and humble submission, I SI. Manoj Kumar Roy of Matigara P.S do hereby lodge this written complaint to the effect that today on 10/06/2025 I was deputed to perform special Raid duty along with force, since 06:05 hrs vide Matigara P.S. C.C. No. 1802 /2025, Dated 10/06/2025 and Matigara P.S. GDE No. 483, Dated -10/06/2025 in course of said special raid duty I received a source information that one Truck was coming from Balasan River loaded with River bed Materials towards Khaprail More under Matigara PS, which was procured clandestinely. On received of such information, I informed the matter to I/C Matigara PS over phone and as per his kind direction myself along with force rushed to Balasan River side and on way at Balasan Bridge under P.S.- Matigara we found one Vehicle (Dumper style as TATA) bearing Regn. No. WB 73 D 0216 loaded with river bed materials in a high speed running toward Siliguri Side, somehow we managed to stop the vehicle and on demand the driver/owner of the vehicle could not produced any valid document in respect of the said loaded materials. It is crystal clear that the driver/owner of the vehicle (Dumper Style as TATA) bearing Regn. No. WB 73 E 0216 procures the river bed materials from somewhere clandestinely and illegally and was preceding to sale the same to their designated customer for their wrongful gain. Accordingly, I seized the vehicle having Regn. No. WB 73 E 0216 loaded with River Bed Materials on the spot i.e. Balasan Bridge with proper seizure list followed u/s 105 of BNSS also arrested the driver of the seized vehicle namely Santosh Mandal (36 Yrs/Male) S/O Kumar Mandal of Bhuttabari, P.S. Bagdogra Dist. Darjeeling and also communicated him the ground of his arrest. Brought the seized vehicles to Matigara P.S and kept at P.S Compound and the arrested accused kept him into the P.S Lock up after maintaining proper Hazat rules. The whole process of Seizure was made in between 07.50 hrs to 08.00 Hrs.

I therefore pray before your esteem that a specific case under proper section of Law may kindly be registered against the accused driver of the seized vehicle namely Santosh Mandal (36 Yrs/Male) S/O Kumar Mandal of Bhuttabari, P.S. Bagdogra, Dist. Darjeeling and arrange for its investigation.
