Sub: Written Complaint

Sir,

I, Rabina Basfore wife of Bickky Bashfore @ Bickky Mallick resident of NJP, North Colony, Gate Bazaar, PS- NJP, Dist- Jalpaiguri beg to inform you that my marriage was solemnized with the aforesaid Bickky Bashfore on 02/03/13 according to Hindu rites and customs at my parental house at Gate Bazaar, PS- NJP, Dist- Jalpaiguri.

At the time of our marriage, my parents had provided a cash of Rs. 1,25,000/-, a motorcycle valued at Rs. 75,000/-, 1 ½ Bhoori Gold Ornaments and some furniture, bedding and other household utensils as per the demand of my husband and his family members. Thereafter, both of us started residing as husband and wife at my parental house at Natun Para, P.O. - Siliguri Bazaar, PS- Siliguri, Dist- Darjeeling. Thereafter, out of the wedlock in between us, a male child was born on 16th June, 2014.

However, there were significant changes in the behavior of my husband since the birth of my child. He along with his family members started torturing me both mentally and physically. Moreover, my husband kept on threatening me about marrying another woman for fulfilling of demands of dowry. Consequently, I was forced to take shelter at my parental house. Thereafter, I had lodged a written complaint against my husband and mother in law at Siliguri Women PS and in respect of which, a specific case was started vide Siliguri Women PS Case No. 16 of 2015, U/S 498A IPC. However, in spite of which, there was no significant changes and they kept on torturing me.

It is pertinent to be mentioned herein that my husband denied to live with me as husband and wife and continuously, I have been subjected to serious mental torture by my husband and his mother. My husband with the instigation of his mother has been continuously torturing me both physically and mentally ever after lodging the aforesaid case. Thereafter, I came to know that my husband has already married another woman namely Maya @ Rupali and started to live with her as husband and wife in another place. Thereafter, on further scrutiny, I also came to know that the said Maya @ Rupali

has given birth to a female child at Chetna Clinic cum Nursing Home, SF Road, Siliguri. Accordingly, on 27/05/25 I rushed to the said nursing home and after scrutiny, I found that the said Maya @ Rupali has given birth to a female child whose father's name is Bickky Bashfore.

It is to be mentioned herein that both me and my husband are Hindu by religion and our marriage was solemnized on 02/03/13 according to Hindu rites and customs at my parental house. Thereafter, a male child was also born out of our wedlock. But inspite the existence of me and my son and without getting any prior divorce, by husband has married again another woman namely Maya @ Rupali and cohabited their relation resulting to the birth of the aforesaid female child.

All of the above mentioned incidents have caused me serious mental agony causing delay in lodging this written complaint. Hence, you are requested to take appropriate legal actions against my husband namely Bickky Bashfore, the said woman namely Maya @ Rupali and his mother namely Kaushalya Bashfore respectively and oblige me.
