I, Md. Maksud, Son of Md. Jahur Ansari, resident of Prakash Nagar, Sevoke Road, Siliguri, Ward No.43 of Siliguri Municipal Corporation, Post Office - Sevoke Road, Police Station-Bhaktinagar, District-Jalpaiguri, PIN-734001 would like to inform you that on 06.06.2025 at 9:00 p.m. some of my staff members informed me that the lock of their room was opened immediately upon hearing this I rushed to my house at about 09:05 p.m., when I reached my house room situated at Prakash Nagar I was absolutely shocked to see that the lock outside my room was cut by a grinder and was completely damaged.

Upon entering my room, I found that all the household items inside my room was moved here and there. When I thoroughly checked my almirah I found that 3 (three) gold rings weighing about 5 grams each approx., gold mangalsutra of my wife weighing about 10 grams approx., 1 (one) pair gold earrings weighing 15 grams approx., cash amounting to Rs.18,000/- (Rupees Eighteen Thousand) approximately was missing and stolen. Certain documents including Original deeds of my landed property being Deed No. I- 7271 of 2024 registered at the office of A.D.S.R., Bhaktinagar and Deed No. I- 1324 of 2020 registered at the office of D.S.R., Jalpaiguri along with all the chain deeds as well as Original Policy Deeds pertaining to my LIC policies being nos. 135678768 and 493988210 were also missing and stolen. Be it mentioned that all the gold articles were gifted to my wife during our marriage.

I was not able to lodge this complaint on the date of incident itself considering the fact that I was engaged in the Eid festivities.

Under the aforesaid circumstances I request you to investigate the matter and book the culprits involved in the crime in accordance with the appropriate provisions of law and further request you to help me to recover my stolen articles.
