Sir,

I, Tapash Kundu, son of Tapan Kundu, resident of Vill:- Thiknikata, P.O Sushrutnagar, P.S. Matigara, Dist. Darjeeling, PIN 734012, would like to inform you that yesterday, i.e, on 07/06/2025 at about 4:30 p.m, when I went to Radha Krishna Mandir Ground to ask one Kishor Bhagat, son of Kailash Bhagat, resident of Vill:- Thiknikata, P.O Sushrutnagar, P.S. Matigara, Dist. Darjeeling, PIN 734012, who is a cricket coach in the said ground, that if my son and his friends could use some space of the ground to play football, but suddenly he denied and started to threaten and abuse me and when I objected him, he called his brother-in-law Mithu Saha, resident of Vill:- Thiknikata, P.O Sushrutnagar, P.S. Matigara, Dist. Darjeeling, PIN 734012, and within two minutes his brother-in-law came and then both of them started verbally abusing me and then suddenly said Kishor Bhagat started to slap me and started drawing punches towards me and as a result I fell down and after I fell down both of them started to kick me in my chest with the intent to cause voluntary hurt, and said Kishor Bhagat picked a wicket Stump and started hitting me in my face and head and also caught hold of my neck and choked me with the intent to kill me and forcefully snatched the gold chain from my neck and when I shouted for help the passerby people came and rescued me as a result of such assault I am having severe headache and partial hearing loss in my left ear. It is to mention that at 6:30 p.m the same day when my mother namely Alo Kundu went at the house of said Kishor Bhagat to seek clarification and settle the matter, said Kishor Bhagat started abusing my mother with filthy languages and physically attacked my mother and also tore her sari thereby outraging her modesty, but somehow my mother came back and told me about the incident. I could not lodge the complaint immediately due to the physical and mental trauma caused by the incident, for which I required some time to recover and also in fear of retaliation by the said Kishor Bhagat, who holds a position of authority. Now, I am very much in fear of my life and limb.

So, you are requested to kindly set the law of land in motion and impart me justice
