Meghnath Sah 2. Munna Sah 3.Rohit Sah all are my neighbors

That on dated-08/06/2025 around 10 Pm my son Aditya Thakur aged about 20 yrs, student by profession who went to shop for purchasing some grocery item and that time Munna sah and Rohit who was in drunken situation stop my son and abusing him in filthy languages when my son started protest then they started beaten my son when my son felt on the ground they keep the money who he keep for purchasing grocery around Rs.1000/-, when my son try to save his life then the person Rohit Prasad hit on his head he have a cut in left ear when I hearing shouting of my son and ran away to save him then Munna Sah & Rohit Sah along his father stated slap me they grab my hair and assaulting me in physically. they beteen my son in their legs they hit on stomach and aditya thakur who keep a blade who try to attack my son's face but local people save me and my son either they kill us. In this incident my son have grievous injury in his body and yesterday he was admitted in siliguri district Hospital and today the doctor release him.

So Due to this I could not lodge this F.I.R Yesterday but today they agagin come at my house and threatened me again. Now it is humble request before you to kindly take legal action against all the person's namely 1.Meghnath Sah 2. Munna Sah 3.Rohit Sah and take necessary step from ends For the justice
