Sir,

In producing herewith following seized articles as per seizure list viz:- i) One Maroon colour goods carrier displaying registration No. WB 76 2123, loaded with river bed materials and ii) 03 numbers of shovels.

I, SI Rajiv Subba of Pradhannagar PS, Siliguri Police Commissionerate, do hereby lodge this written complaint against the vehicle owner and driver of the vehicles having registration No. WB 76 2123. To the effect that on today (11.06.2025) at 06:30 hrs received a specific source information that illegal mining of river beds materials is going on at Mahananda river bed, Military Ghat, under Pradhannagar Police Station. The matter has been diarized vide Pradhannagar PS GDE No. 607 dated 11.06.2025. The matter was immediately brought to your notice, upon which I was directed to verify the information. Accordingly, I, along with SI Goutam Mallik, SI Bandhan Roy, ASI Biplab Kumar Das, and other police personnel proceeded to the spot using a government vehicle.

Upon reaching the location, the source updated us that a vehicle bearing registration number WB 76 2123, loaded with river bed materials, had already departed towards Sraman Nagar to deliver the consignment to its designated customer. We proceeded towards Sraman Nagar and at approximately 07:05 hrs, we located the vehicle on route at Sraman Nagar, Krishnamore, Champasari, Pradhannagar Police Station, Darjeeling. Upon spotting police personnel, the driver accelerated the vehicle in an attempt to flee. However, due to the heavy load of the river beds materials, the driver eventually abandoned the vehicle and fled on foot.

On inspection, it was found that the vehicle was loaded with illegally mined river bed materials, including three shovels. Preliminary enquiry we found that the owner and driver of the vehicle have been engaging in the illegal mining of river beds materials and sale of such materials for wrongful gain over a period of time.

Accordingly, I seized the vehicle and tools under a proper seizure list, in the presence of witnesses. The whole process of search, seizure and label were made under the coverage of videography, in between 07:10hrs to 07:30hrs as per provisions of BNSS, and hereby submit this written complaint for initiating a case under appropriate sections of law against the vehicle owner, and the driver of the seized vehicle (WB 76 2123), and arrange for its investigation.
