On dated 11.06.2025 at 14.00 hr I along with accompanying WBSEDCL team viz. 1) Bhaben Roy S.O S&LP of Darjeeling Regional Office, WBSEDCL, 2) Abhishek Roy of Matigara CCC, WBSEDCL 3 ) Patilal Rai of Matigara CCC 4) Sanjoy Ram of Matigara CCC have entered the premise of Manoj Kumar Gupta under Matigara CCC. During inspection it has been found that total amount of 2124.00 (OSD) as on 11.06.2025 is pending as electricity outstanding bill for consumer id 412066155 of Manoj Kumar Gupta. It is also found that said connection under con id : 412066155 was disconnected for not paying electricity bill on 09.01.2025. At the time of inspection, it came to our notice that said disconnected line has been reconnected illegally without clearing outstanding dues from another meter of consumer ID : 401287731 of Manoj Kumar Gupta by illegal extension of service.
