Respected Sir,

I, Manish Sau, son of Indradev Sau, resident of Jyoti Nagar Colony, Tumul Para, Ward No. 4, Siliguri, am filing this FIR to report a serious incident of physical assault and threats that occurred on June 9, 2025, between 10:30 pm and 11:00 pm near Mahananda 4th Bridge, Jyoti Nagar, Tumul Para, Ward No. 4, Siliguri by a group of unknown 7 People, With help of local I get to know One of them is Zuber Khan, S/o Murtaza Khan, resident of Gawalapatty, Word no 4, Siliguri.

While I was sitting at a momo stall and engaged in a phone call, a person behind me started shouting loudly and using vulgar language. When I politely asked him not to shout, his friend became enraged and started abusing me. The situation escalated as they made a phone call and brought more 6 people, including one person's mama and One them is Zuber Khan as I mentioned. These individuals brutally dragged me near a wall, held my hands, and physically assaulted me with kicks, slaps, and punches on my legs, hips, and other parts of my body. I saw some of them carrying bamboo sticks and metal hazardous instruments like knives, which made the situation even more terrifying, at that point Somehow I escape to from that place I was alone in that situation

During the assault, they threatened to kill me and also threatened the security of my sisters at home. As the sole male member of my family, I am now engulfed by fear and anxiety, unsure of how to ensure my safety and that of my family members.

I humbly request that you take immediate action conduct a thorough investigation into the incident and take appropriate legal action against the perpetrators, including Zuber Khan, son of Murtaza Khan, Provide protection to me and my family, especially my sisters, from any further harm or threats. Consider the trauma and fear that I have endured and take necessary steps to ensure my safety and well-being.

I am willing to cooperate fully with the investigation and provide any additional information or evidence required.
