I, NIRMALA JOSHI, W/o Late Shashikant Joshi, Hindu by religion, Indian by Nationality, resident of New Ghosh Mansion, 1st Floor, Seth Srilal Market, Ward No. 11, Siliguri -734001, P.O. & P.S. Siliguri in the District of Darjeeling do hereby inform you as follows:

I have been residing at a tenanted premises i.e a flat located at the 1st Floor of the building named New Ghosh Mansion, Seth Srilal Market, Ward No. 11, Siliguri -734001, 40° P.O. & P.S. Siliguri. I have been residing at the aforesaid flat for the last 30 years as a tenant. As I had been residing at the aforesaid flat for such a long time, I have also obtained an electricity connection in my name and have also been paying the electricity such a regular basis.

I am a widowed lady and I reside alone at my residence and taking advantage of this situation Mr. Dipankar Ghosh (Mobile No. 8250683423) and Mrs Sangita Ghosh who reside at the adjacent building have been continuously harassing me by various means such as deliberately shutting down the water supply of my residence, cutting the electric connection, making absurd and obscene remarks and thus causing immense mental as well as physical distress to me. the abovenmaed Mr. Dipankar Ghosh is my landlord and he has been resorting to such means to torture me and eventually force me to vacate the rented flat. As I am a widowed lady having no support whatsoever and with nowhere to go, I continued to bear the daily torture.

I am suffering from various health issues and such I fell severely ill and in order to take care of my health my daughter took me to her house situated at Sarkar Para in Siliguri, and I had been residing there since the last three months. That day before yesterday at about 7:30 Pm (i.e., on 09.06.2025) when I returned back to my residence, I was shocked to see that grill gate to my residence had been broken and a new lock had been installed

on my gate. Upon enquiring from my neighbours it has come to my knowledge that the aforesaid Mr. Dipankar Ghosh along with his family members had replaced the old lock by placing a new lock and has also removed the grill gate which was installed at the entrance of my residence. That today morning when I, with the help of my neighbours and few local residents entered into my residence, I was shocked to see that as my entire belongings like my furniture, almirah, utensils had been stolen from my flat. I understood that the act of breaking the lock to my house and has been done by the aforesaid Mr. Dipankar Ghosh, Mrs Sangita Ghosh, their daughter and staff members of their restaurant Desi gully who reside nearby. In the prevailing circumstances it is clear that it is a planned act of the aforesaid Mr. Dipankar Ghosh, his family member and staff members to forcefully enter into my flat/house without my permission by breaking the grill and lock to my house and also stealing all the belongings kept at my house, most importantly they have also stolen all the almirah wherein I had kept all my documents such as my id cards, rent agreement of the flat, rental receipts, my electricity bills and all other important documents, further cash amount of Rs. 32,000/- (approximately) and gold and silver ornaments worth Rs. 5,00,000/- were also stolen from my house.

I am a helpless widowed lady and have nowhere else to go and I have thus come to your asylum seeking your help to help me recover my belongings from the aforesaid persons and also stay at my residence peacefully without the fear of my life, as the aforesaid persons are very dangerous and may cause hurt to me at any point of time.
